In accordance with 42 CFR §440.386, the Division of Health Care Financing and Policy is proposing an amendment to the Alternative Benefits Plan to the State Plan for Medicaid Services that would allow for Community Paramedicine services. The state assures compliance with 42 CFR 440.345 to provide full access to Early Periodic Screening, Diagnosis, and Treatment (EPSDT) services for covered participants by describing the process to access these benefits in Medicaid Services Manual (MSM) Chapter 1500, Healthy Kids Program.
