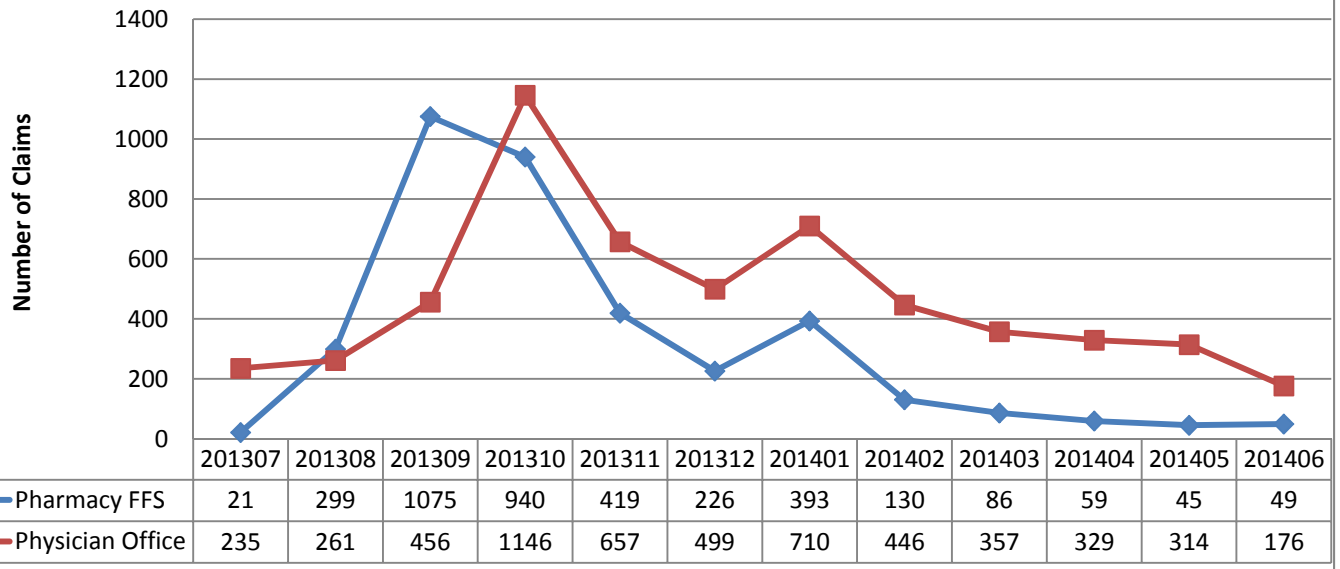

Nevada Medicaid Fee for Service Vaccine Utilization

July 1, 2013 – June 30, 2014

In April 2012, Nevada Medicaid and Nevada Check-Up initiated a program to allow retail pharmacies to bill and administer vaccines. The below graph represents the number of claims by place of service from the date July 1, 2013 to June 30, 2014. The increase in claims from August 2013 to November 2013 is due to administration of the influenza vaccine. The increase in January 2014 is likely due to the increased number of members enrolled in Nevada Medicaid. The Vaccines for Children (VFC) Program supplies vaccines for children enrolled in Fee for Service and Nevada Checkup. Providers must receive their vaccines from the VFC program. Nevada Medicaid pays a fee to providers for administration of the vaccine.
