2. DHCFP – Updates

- <u>ABA SPA</u> CMS approved the ABA State Plan 3-10-2016 with the policy effective date January 1, 2016. Providers are to submit their prior authorization and billing as per Provider Type 85 billing guide. These rates were a result of Public Hearing October 2015
- b. <u>Recycle of claims</u> Billing that has previously been submitted and denied due to lack of CMS approval of the SPA should now be recycled and put through for payment.

3. DHCFP – Surveillance Utilization Review Section (SURS) – Updates

a. <u>SURS Overview</u> – The Surveillance and Utilization Review Unit guards against fraud and abuse by providers. These functions include (not all inclusive) detecting areas where Medicaid regulations can be improved, identifying contradicting policy, and conducting training on fraud and abuse. 4. HPE – Updates

a. <u>FA 11-E</u> – The FA 11-E was updated February 17, 2016. Please begin using the new form now. Effective May 1, 2016 requests for ABA services submitted on the old form will not be accepted.

Parents must sign the FA 11-E and providers must complete the form in its entirety.

b. <u>FA 11-F</u> – The FA 11-F form was updated February 17, 2016. Please begin using the new form now. Effective May 1, 2016 requests for ABA services submitted on the old form will not be accepted.

The FA 11-F is needed at the initial request for services. This is not needed for concurrent requests.
