ABA Rates were developed utilizing the following information: CPT Category III Code Rates (Medicare), Medicaid Policy, National Review of ABA Provider Salaries, Staff Developmental and Credentialing Costs, normal costs of doing business such as FICA, Health Care Costs, Sick & Vacation Leave, FUTA, Medicare, Workers Comp, Unemployment, Business Taxes, Supervision, Training and Certification Costs, Productivity Adjustments, Indirect and Non-billable Costs, Documentation Requirements and Travel Costs.
