  - a. Web Announcement 996 <u>HP Web Announcement 996</u> this announcement is to ensure Provider Type/Specialty has access only to the codes they may bill for per the Medicaid Management Information System (MMIS). This update took place September 30, 2015
  - b. Web Announcement 998 <u>HP Web Announcement 998</u> this announcement is to announce that a online web-based provider enrollment portal will be available starting November 16, 2015. This is to assist with new enrollees, revalidation and provider changes. If you have any questions, you can call providers support at (702) 334-1622

Administrative changes FA-33 <u>HPE Provider Enrollment FA-33</u> Medicaid providers, and any pending contract approval, are required to report, in writing within five working days, any change in address, or addition or removal of practitioners, or any other information pertinent to the receipt of Medicaid funds. Failure to do so may result in termination of the contract at the time of discovery (per Medicaid Services Manual, Chapter 100)
