Use of the FA-33 form to Update the "Mail To Address", Phone Number or Email address with information that is directly associated with the provider. Many agencies update this information with their own information which causes the provider themselves to not have contact information for the specific provider's NPI number. When a provider is linked or unlinked, the contact information is not updated and thus we are left without contact information that goes directly to the provider. Updating current contact information is helpful should anyone at HPE or DHCFP need to get information conveyed directly to the individual provider.
