Updates or reminders for Providers: Kurt Karst, Surveillance and Utilization Review (SUR) Unit.

- a. Surveillance and Utilization Review (SUR) would like to remind providers that if you are no longer affiliated with a company, you must update your information per your provider enrollment packet and MSM Chapter 100.
- As a reminder, if you are a clinical supervisor, you must comply with your responsibilities as a clinical supervisor per policy as we can hold you responsible for direct supervision. Please review policy within MSM Chapter 400 pertaining to direct supervision responsibilities.
