Renewal Periods

This page highlights the new timeline for each renewal period; DWSS renewal periods will restart January 2024 and end at the end of August 2024 for September 2024 renewals.

> March Renewal Renewal activities occur between 1/1/2024 - 2/29/2024

> > Feb 2024

The end of Unwinding was originally schedule to end at the end of May 2024. Due to Nevada's Mitigation Plan, the timeline was extended from May 2024 to end of August 2024.

> **February Renewal** Renewal activities occur between 12/01/2023 - 1/31/2024

> > Jan 2024

Reinstatements between June and September were given a 12-month Renewal Date:

June 2024 (Renewal due 5/31/24) July 2024 (Renewal due 6/30/24)

Paused Procedural Terminations months were given 6 months continuous eligibility for those who terminated for procedural reasons. Renewal Dates are as follows:


The last day of eligibility



January Renewal Month

This map highlights renewal activities for an individual whose renewal month is January 2024.

- 1. On approximately October 15th DWSS will attempt to renew eligibility using available information and data sources without contacting the beneficiary (ex parte) at an individual level.
- 2. If ex parte is unsuccessful, DWSS will send a renewal packet on November 1st 60 days prior to the renewal month (January 2024).
- 3. The beneficiary has 60 days to return the renewal packet. If they return it but DWSS needs more information, DWSS will send a Request for Information.
- 4. If the individual is no longer eligible they will receive a notice 10 days prior to the due date their eligibility will end.
- 5. If the individual continues to be eligible the renewal date will advance to the following year.
