Dear Tribal Members:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy:

The DHCFP is proposing revisions to Medicaid Services Manual (MSM), Chapter 1200 – Prescribed Drugs, Appendix A, to reflect recommendations approved on January 23, 2020 by the Drug Use Review (DUR) Board. The proposed changes include addition of prior authorization on Zelnorm® (tegaserod), Nayzilam® (Midazolam) and agents used for relapsing form of Multiple Sclerosis (MS). Additionally, revisions to existing prior authorization criteria for monoclonal antibody agents and narcolepsy agents will be noted.

There is no anticipated fiscal impact to the Tribal Governments.
