Dear Tribal Members:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy:

The DHCFP is proposing revisions to Medicaid Services Manual (MSM) Chapter 1200, Appendix A, Diabetic Supply Program policy by adding language specific to preferred and non-preferred diabetic products and supplies, adding clarification language for when a prior authorization is required/not required, and providing language specific to Continuous Glucose Monitors with special features for recipients with an impairment. Lastly, it is proposing revisions to Antihepatitis Agents policy by updating the age indication for Epclusa® based on updated FDA indications.

There is no anticipated fiscal impact to the Tribal Governments.
