Dear Tribal Members:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy:

The DHCFP is proposing to make a 6% rate reduction to all Provider Types (PTs). Nevada Medicaid enrolled Indian Health Programs (PT 47), including Indian Health Service facilities and Tribal 638 facilities are reimbursed in accordance with the most recently published Federal Register, hence this rate reduction will not have an impact to PT 47s. This rate reduction is being made in an effort to reduce current costs to the Medicaid program and to address the Governor's mandated budget cuts.

At this time, the fiscal impact for State Fiscal Year (SFY) 2021 is estimated to result in an approximate savings of \$221,607,183.

There is no anticipated impact to the Tribal Government.
