Dear Tribal Members:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy:

The DHCFP is proposing updates to Medicaid Service Manual (MSM) Chapter 190 – Transportation Services, Section 1904, Non-Emergency Transportation (NET) Services, to align policy with amendments made to the contract held with the DHCFP's NET vendor, Medical Transportation Management, Inc. (MTM). The changes remove meal reimbursement and lodging as a covered transportation benefit, it will require recipients to request transportation to any out-of-area medical appointments at least 21 days in advance, and transportation of an escort traveling with a recipient to and from a Residential Treatment Center will no longer be covered. Additionally, the reimbursement language for Indian Health Programs and Tribal Community Health Representatives (CHRs) clarifies the reimbursement rate is equivalent to double the IRS business mileage rather than the IRS medical mileage; this does not affect the current rate Indian Health Programs and Tribal CHRs are being reimbursed. As with all policy updates, grammatical changes were made, acronyms used and standardized, and language was reworded for clarity. Renumbering and re-arranging of sections may also be necessary.

There is no anticipated fiscal impact to the Tribal Governments.
