Dear Tribal Members:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy:

Revisions to Medicaid Services Manual (MSM), Chapter 1200, Appendix A, are being proposed to reflect recommendations approved on October 17, 2019 by the Drug Use Review (DUR) Board. The proposed changes include revisions to existing prior authorization criteria for Hematopoietic/Hematinic Agents based on FDA indications.

There is no anticipated fiscal impact to the Tribal Governments.
