Dear Tribal Members:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy:

The DHCFP is proposing revisions to Medicaid Services Manual (MSM) Chapter 1200 – Prescribed Drugs, Appendix A, to reflect recommendations approved on April 30, 2020 by the Drug Use Review (DUR) Board. The proposed changes include revisions to the existing prior authorization criteria to the Proton Pump Inhibitors (PPIs) Agents, revisions to the existing prior authorization criteria for Toradol<sup>®</sup> (ketorolac tromethamine) tablets, addition of new prior authorization criteria for Ubrelvy<sup>®</sup> (ubrogepant), Emgality<sup>®</sup> (galcanezumab-gnlm), Aimovig<sup>®</sup> (erenumab-aooe) and Ajovy<sup>®</sup> (fremanezumab-vfrm), addition of a new sickle cell agents' section to include new prior authorization criteria for Adakveo<sup>®</sup> (crizanlizumab-tmca) and Oxbryta<sup>®</sup> (voxelotor), addition of new prior authorization criteria for Trikafta<sup>®</sup> (elexacaftor/tezacaftor/ivacaftor and ivacaftor) and lastly, addition of new prior authorization criteria for Wakix<sup>®</sup> (pitolisant).

There is no anticipated fiscal impact to the Tribal Governments.
