Dear Tribal Members:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy:

The DHCFP is proposing updates to Medicaid Service Manual (MSM) Chapter 1900 - Transportation Services, Section 1904 Non-Emergency Transportation (NET) Services due to Assembly Bill 66 (AB66) from the 2019 Legislative Session. Policy updates include defining coverage of Non-Emergency Secure Behavioral Health Transport Services as the use of a motor vehicle, other than an ambulance or other emergency response vehicle, that is specifically designed, equipped and staffed by an accredited agent to transport a person alleged to be in a mental health crisis or other behavioral health condition, including individuals placed on a legal hold.

The DHCFP is also proposing updates to the Medicaid State Plan Attachment 3.1-A - Amount, Duration and Scope of Medical and Remedial Care and Services Provided to the Categorically Needy (Pages 9, 9a, and 9b) and Nevada Medicaid State Plan Attachment 3.1-D - Transportation (Pages 1 and 2) to include Non-Emergency Secure Behavioral Health Transport Services. Attachment 4.19-B - Payment for Medical Care and Services (Pages 4.4 and 4, addendum) will be updated with rate calculation methodology for Non-Emergency Secure Behavioral Health Transport Services.

In addition, the DHCFP is proposing updates to the Medicaid Alternative Benefit Plan, ABP5, Section 14 - Other 1937 Covered Benefits that are not Essential Health Benefits (Page 34), to include the service of Non-Emergency Secure Behavioral Health Transports.

The anticipated federal fiscal impact for Federal Fiscal Year (FFY) 2021 is \$758,903 and FFY 2022 is \$1,597,338.

There is no anticipated fiscal impact to the Tribal Governments.
