Dear Tribal Members:

Nevada Medicaid has received application and authority approval by the Center for Medicare & Medicaid Services (CMS) for a section 1115(a) demonstration titled "Nevada's Treatment of Opioid Use Disorders (OUDs) and Substance Use Disorders (SUDs) Transformation Project" effective January 1, 2023 through December 31, 2027. Approval of this demonstration will enable the state to receive federal financial participation (FFP), for otherwise covered Medicaid state plan services that are furnished to otherwise eligible individuals who are primarily receiving treatment and withdrawal management services for substance use disorder (SUD) as short-term residents in facilities that meet the definition of an institution for mental diseases (IMD). More specifically, the American Society of Addiction Medicine (ASAM) levels of care that will be reimbursable within an IMD setting are:

- ASAM Level 3.1 Clinically Managed Low-intensity Residential Services •
- ASAM Level 3.2 Clinically Managed Residential Withdrawal Management •
- ASAM Level 3.5 Clinically Managed High-Intensity Residential Services
- ASAM Level 3.7 Medically Monitored Inpatient Withdrawal Management

Additionally, this demonstration provides expenditure authority for enrollees of the Children's Health Insurance Program (CHIP) who move into an IMD while enrolled, or individuals who would otherwise be eligible for CHIP but who are residing in an IMD at the time of application or renewal.

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy:

The DHCFP is proposing revisions to MSM Chapter 400 – Mental Health and Alcohol and Substance Abuse Services to align Chapter language with the flexibilities reimbursable with the authority of the 1115 Demonstration Waiver and to remove outdated language.

Fiscal Impact to Tribal Governments is unknown at this time.
