**Dear Tribal Members:** 

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy and State Plan Amendment:

The DHCFP is proposing to update policy language in Medicaid Services Manual (MSM) Chapter 600 – Physician Services, Gender Reassignment Services, as a result of the passage of Senate Bill 163 during the 82<sup>nd</sup> (2023) Legislative session. The proposed language change is to include medically necessary treatment of conditions relating to gender dysphoria and gender incongruence as a covered benefit. The updated language to MSM 600 also includes removing cosmetic surgery as a non-covered service and allowing certain cosmetic procedures if deemed medically necessary. In addition, an update to the Nevada Medicaid State Plan at Attachment 3.1-A Page 2 & Page 2 (cont) and Attachment 2.1-A Page 2I is being proposed to revise physician services whether furnished in the office, the patient's home, a hospital, a nursing facility or elsewhere as a provided service with limitations. The proposed update will also include the addition of section 5.a. which indicates cosmetic surgery performed by a plastic surgeon or reconstructive surgeon or any gender affirming or gender transition treatment for an individual who has been diagnosed with gender dysphoria or gender incongruence, when such surgery does not meet the definition of medically necessary as described under state law and further outlined in the Nevada Medicaid Services Manual Chapter 103.1, is not an allowable service.

There is no anticipated fiscal impact to Tribal Governments.
