Dear Tribal Members:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy:

The DHCFP is proposing language updates to multiple areas of the State Plan Amendment (SPA) as well as multiple chapters of the Medicaid Services Manuals (MSM). Language will be updated changing "Residential Treatment Center (RTC)" to "Psychiatric Residential Treatment Facility (PRTF)." This change is to align with the appropriate language and facility type per the Centers for Medicare and Medicaid Services (CMS). This is not a change to policy. The following sections of the State Plan and Medicaid Services Manuals will be updated:


There is no fiscal impact to the tribes.
