Dear Mr. Ellery:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy regarding non-emergency transportation services for Nevada Check Up (NCU) recipients effective August 1<sup>st</sup>, 2010.

Updates are being proposed to Medicaid Services Manual, Chapter 1900 to aid the State of Nevada with cost containment and to help recipients access the most appropriate NET services for their needs. Included in the chapter changes are provisions which may affect Indian Health Service providers. Section 1904.2.N establishes the rate for NET services in private vehicles to medically necessary covered services and are reimbursed at a per mile rate that is double the Internal Revenue Service medical/moving mileage rate. In the past rates were negotiated at infrequent periods. The new method provides a continuing update of mileage reimbursement rates.

Using Logisticare's data, Washoe Tribal Health Clinic was reimbursed for 2,797 miles for a total of \$978.95 for the year 2009. The change to the payment methodology would have reduced the amount to \$923.01, **a financial impact of a negative \$55.94 for the year.**

Another change which may affect Native American recipients is that recipients who require a level of non emergency transportation services above bus passes or mileage reimbursement may be required to have an assessment of needs done by the Medicaid District Office in order to better match services to recipients.

Also included in the changes to Chapter 1900 are changes in non-emergency transportation policy regarding nursing homes, adult day health care, foster and adoptive parents, and how the NET broker subcontracts with other vendors.

A public hearing for the changes to Medicaid Services Manual 1900 will be held on June 29, 2010 at 9:00 a.m. An agenda and full text of the amended chapter for the public hearing may be found on line at <https://dhcfnv.gov/publicnotices.htm>. The locations for the hearing are:
