In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in state plan.

The Division of Health Care Financing and Policy (DHCFP) intends to submit a state plan amendment to revise the Enhanced Rates for Practitioner Services delivered by the University of Nevada School of Medicine. The local government entity affected by this change will be University of Nevada School of Medicine.

Our intention is to have a public hearing on the amendment sometime in December and have it become effective December 1, 2011.
