Revisions to MOM Chapter 600 are being proposed to add language to address a decrease in the participant's level of care (LOC). If during a re-evaluation the participant's LOC is decreased, the maximum allowable costs will be decreased accordingly.

4. For Possible Action: Discussion and proposed adoption of MSM Chapter 2700 – Certified Community Behavioral Health Clinic (CCBHC)

#### Ms. Alexis Tucey;

MSM Chapter 2700 is being proposed as a new chapter. The DHCFP is proposing a new chapter for the Certified Community Behavioral Health Clinic (CCBHC) demonstration grant awarded by the Substance Abuse and Mental Health Services Administration (SAMHSA) in collaboration with the Centers for Medicare and Medicaid Services (CMS). This is a two-year demonstration grant and is designed to create integrated care and coordination of quality care for improved health outcomes for individuals with behavioral health disorders. This chapter will outline the provider qualifications, services and the description and intent of CCBHC delivery model.

The Following PT will potentially be affected by this change:

PT 17 Specialty 188, has been developed for this two-year demonstration. This will not impact currently existing providers as this will create formal relationships with other providers and community services for an integrated care model.

Financial Impact on Local Government: Unknown at this time.

The effective date is July 1, 2017.

<u>Ms. Foster</u> – Recommended the Deputy Administrator approve as submitted with the following changes:

- Section 2701, second bullet point, spell out acronyms HHS to include Health and Human Services and PHS to include Public Health Service.
- Section 2702P, add "mental health disorders and" to read "...recovery from mental health disorders and substance use..."
- Section 2703.1B, insert a comma after the word "domains."
- Section 2703.2, remove the word "and" and insert comma to read "Substance Abuse, Prevention and Treatment Agency."
- Section 2703.4A(3), remove the word "care for" and replace with "that."
- Section 2703.6B(4), insert a comma after word "Ambulatory" and add "detoxification,"
- Section 2703.10B(2)(b), add the word "and" to read "...are seen and initial evaluation..."
- Section 2703.16, add hyperlink for Allowable Services Grid.
- Section 2703.16C, change "this" to "their" to read "...monitor their disease(s)."
- Section 2703.16F, insert a comma after the word "report."
- Section 2703.19A, change "payment perspective system" to read "prospective payment system."

- Section 2703.20A(7), add "and" to end of sentence.
- Section 2703.20A(8), remove sentence.
- Section 2703.20A(9), renumber to 8.

Ms. Sprout – Approved as submitted with the changes as read in.
