Subject: Covered Outpatient Drugs - Pharmacy

As a result of the implementation of the Covered Outpatient Drug final rule with comment (CMS-2345-FC) (81 FR 5170) published on February 1, 2016, the Division of Health Care Financing and Policy (DHCFP) will be submitting a State Plan

Amendment (SPA) to the Centers for Medicare and Medicaid Services (CMS) that will address the changes for determining reimbursement methodologies for Covered Outpatient Drugs (Pharmacy).

The Nevada State Plan, Attachment 4.19-B, Page 3, will be updated to reflect these changes.

The following Provider Types (PTs) will potentially be affected by this change: All PTs that dispense covered outpatient drugs will potentially be affected by these changes.

Estimated Change in Annual Aggregate expenditures: No change in annual aggregate expenditures is anticipated.

The effective date of change is April 1, 2017.
