Revisions to MSM Chapter 400, Section 403.5C are being proposed to clarify service limitations and prior authorization (PA) requirements for all psychotherapy and neurotherapy services. Proposed changes clarify that all psychotherapy (individual, group and family) and neurotherapy sessions are allowed up to three sessions, of any combination, without a PA. After three sessions, a PA will be required, and may be requested from the QIO-like vendor for additional services above the service limitations for all levels demonstrating medical necessity.

Additionally, proposed changes clarify the Intensity of Services grid for both adolescents and adults to align with service limitations already in policy. This is not a change to policy.

Entities Financially Affected: Providers of psychotherapy and neurotherapy, including, but not limited to, Behavioral Health Outpatient Treatment (Provider Type (PT) 14), Psychologists (PT 26) and Behavioral Health Rehabilitative Treatment (PT 82).

Financial impact on local government: Unknown at this time.
