2. Discussion of proposed amendments to the State Plan for Medicaid Services and solicitation of public comments

Subject: Intensive Outpatient Services (IOP) and Partial Hospitalization Program Services (PHP)

The DHCFP is proposing the removal of Intensive Outpatient Services (IOP) and Partial Hospitalization Program Services (PHP) from the 1915(i) Home and Community Based Services (HCBS) State Plan Attachment 3.1-G, Pages 1, 32, 32a and 32b. Language added to the State Plan Attachment 3.1-A, Page 1a, Sections 2a and 2c, permitting contractual agreements permitting hospitals or Federally Qualified Health Centers (FQHC) to assume clinical liability and administrative oversight to an outpatient clinic providing PHP services. Language added for IOP and PHP services to State Plan Attachment 3.1-A, Pages 6b.4 and 6b.4 (Continued). Rate methodology moved from Attachment 4.19-B, Pages 3b, 3j and 3k for IOP and PHP to the appropriate section of Non-Residential Mental Health Services for non-governmental entities in State Plan Attachment 4.19-B, Pages 17, 17a, 17b, 17c, 18 and 18a. Alternative Benefit Plan Section (ABP) 5, Page 13 has amended the source from the 1915(i) HCBS State Plan Services to State Plan 1905(a), Hospitalization Program Services.

In accordance with 42 Code of Federal Regulations (CFR) §440.386, the DHCFP is proposing an amendment to the ABP to the State Plan for Medicaid Services that would allow for Community Paramedicine services. The state assures compliance with 42 CFR 440.345 to provide full access to Early Periodic Screening, Diagnosis and Treatment (EPSDT) services for covered participants by describing the process to access these benefits in Medicaid Services Manual (MSM) Chapter 1500 – Healthy Kids Program.

The following provider types (PT) will potentially be affected by this change: This proposed change affects all Medicaid-enrolled providers delivering IOP and PHP type of services. Those PTs include but are not limited to: Hospital, Outpatient (PT 12), Behavioral Health Outpatient Treatment (PT 14), Special Clinics (PT 17), Physicians, M.D., Osteopath, D.O. (PT 20), Advanced Practice Registered Nurse (PT 24), Psychologist (PT 26), Pharmacy (PT 28), Durable Medical Equipment (PT 33), Therapy (PT 34), Indian Health Services and Tribal Clinics (PT 47), Home and Community Based Waivers (PT 48), Indian Health Service Hospital, Inpatient (PT 51), Indian Health Service Hospital, Outpatient (PT 52), Targeted Case Management (PT 54), Physician's Assistant (PT 77), Indian Health Service Hospital, Outpatient (Non-Tribal) (PT 79), Applied Behavior Analysis (PT 85).

Estimated change in annual aggregate expenditures: No change in annual aggregate expenditures is anticipated.

The effective date of change is April 1, 2019.

3. Discussion of proposed Amendments to the State Plan for Medicaid Services and solicitation of public comments

Subject: Intensive Behavior Intervention Attachment 3.1-A
The DHCFP is proposing revisions to Nevada Medicaid's State Plan Attachment 3.1-A, to update the changes in the licensing board for Applied Behavioral Analysis (ABA) providers.
The licensing board will be transitioning from the Nevada Board of Psychological Examiners to the Nevada Board of Applied Behavior Analysis effective January 1, 2019. Board Certified

Behavior Analysts (BCBAs) and Board-Certified Assistant Behavior Analysts (BCaBAs) who are not currently licensed by January 1, 2019 will be required to obtain licensure through the Nevada Board of Applied Behavior Analysis. Registered Behavior Technicians (RBT) will be required to register with the Nevada Board of Applied Behavior Analysis beginning January 1, 2019.

This proposed change affects all Medicaid-enrolled providers delivering ABA type of services. Those PTs include but are not limited to: Applied Behavior Analysis (PT 85). This is an opportunity to call this regulation to the attention of providers who may be affected, even if we presume that there will be no financial impact to them.

Estimated change in annual aggregate expenditures: No change in annual aggregate expenditures is anticipated.

The effective date of change is January 1, 2019.

Nevada Medicaid is unaware of any financial impact to other entities or local government due to this public hearing, other than as stated above.
