1. General Public Comments (Because of time considerations, the period for public comment by each speaker or organization may be limited to three minutes and speakers are urged to avoid repetition of comments made by previous speakers.)
2. For possible action: Discussion and adoption of changes to MSM Chapter 1800 – Adult Day Health Care.

Revisions to MSM Chapter 1800 are being proposed to rename the chapter to 1915(i) Home and community Based State Plan Option adult Day Health Care and Habilitation Services. Additional changes include revisions to needs-based criteria, new language under provider responsibilities, addition of Day and Residential Habilitation services, addition of Intake and Ongoing procedures and Termination of 1915(i) services,

Entities Financially Affected: This proposed change affects all Medicaid-enrolled providers delivering Adult Day Health Care Services. Those Provider Types (PT) include Adult Day Health Care services (PT 39) and Habilitation services (PT 55).

Financial impact on local government: There is no anticipated fiscal impact known at this time.

3. For possible action: Discussion and adoption of changes to MSM 2400- Habilitation Services.

Revisions to MSM 2400 are being proposed to obsolete the chapter in order to combine the 1915(i) Home and Community Based State Plan Option services into one MSM which will be MSM 1800.

Entities Financially Affected: This proposed change affects all Medicaid-enrolled providers delivering Habilitation Services. Those provider types (PT) include Habilitation services (PT 55).

Financial impact on local government: There is no anticipated fiscal impact known at this time.

4. For possible action: Discussion and adoption of changes to MSM Chapter 1300 – DME Disposable Supplies and Supplements.

Revisions to MSM Chapter 1300 are being proposed to remove cost invoice verbiage, made reference to PT 33 billing guide, removing External Ambulatory Infusion Pump policy as it is to be moved to the Pharmacy chapter, added verbiage regarding Insulin Systems and Continuous Glucose Monitors to refer to MSM Chapter 1200 Pharmacy, removed rental verbiage under Osteogenesis Stimulator Devices and updated to allow treatment after 3 months of non-healing instead of 6 months, and updated policy to allow home sleep studies to document sleep apneas for Bi-PAP and CPAP equipment.

Entities Financially Affected: This proposed change affects all Medicaid-enrolled providers delivering medical equipment, supplies and supplements. The PTs effected are DME (PT 33) and Pharmacy (PT 28).

Financial impact on local government: Unknown at this time at this time.

5. For possible action: Discussion and adoption of changes to MSM 1200 – Prescribed Drugs

Revisions to Medicaid Services Manual (MSM) Chapter 1200 – Prescribed Drugs are being proposed to align with provision of Senate Bill 378 which consist of changing the name of the Pharmacy and Therapeutics (P&T) Committee to Silver State Scripts Board. In addition, the Division of Health Care Financing and Policy (DHCFP) is proposing to replace the word immunization to vaccines to better align with the US Centers for Disease Control and Prevention (CDC) definition.

Revisions to MSM Chapter 1200 – Prescribed Drugs are being proposed to reflect recommendations approved on October 17, 2019 by the Drug Use Review (DUR) Board. The proposed changes include revisions to the existing criteria for Hematopoietic/Hematinic Agents, Topical Immunomodulators, Lidoderm 5% Patches and Daliresp® (roflumilast). These changes include the removal of criteria for Regranex®, Inhaled Anticholinergic Agents and Natroba® (spinosad). Lastly, the changes include the addition of new prior authorization criteria for Zolgensma® (onasemnogene abeparvovec-xioi).

Entities Financially Affected: Providers who prescribe, dispense or administer this drug may be affected by this change, including but not limited to the following PTs: Outpatient Surgery (PT 10); Hospital, Inpatient (PT 11); Hospital, Outpatient (PT 12); Intermediate Care Facilities for Individuals with Intellectual Disabilities, Public (PT 16); Special Clinics (PT 17); Nursing Facility (PT 19); Physician/Osteopath (PT 20); Podiatrist (PT21); Advanced Practice Registered Nurse (PT 24); Pharmacy (PT 28); Home Health Agency (PT 29); Ambulatory Surgical Centers, Freestanding (PT 46); Indian Health Programs and Tribal Clinics (PT 47); Indian Health Service Hospital, Inpatient (Tribal) (PT 51), Indian Health Service Hospital, Outpatient (Tribal) (PT 52); Transitional Rehabilitative Center, Outpatient (PT 55); Inpatient Rehabilitation and Long Term Acute Care (LTAC) Specialty Hospitals (PT 56); Hospice (PT 64); Hospice, Long Term Care (PT 65); Intermediate Care Facilities for Individuals with Intellectual Disabilities, Private (PT 68); Nurse Anesthetist (PT 72); Critical Access Hospital (CAH), Inpatient (PT 75); Audiologist (PT 76); Physician’s Assistant (PT 77); Indian Health Service Hospital, Inpatient (Non-Tribal) (PT 78); Indian Health Service Hospital, Outpatient (Non-Tribal) (PT 79).

Financial impact on local government: There is no financial impact on local government.

These policy changes are effective ~~February 26~~ March 2, 2020.
