Subject: Disproportionate Share Hospital (DSH) program

Changes are being made to Nevada State Plan Attachment 4.19-A, Pages 23, 32a and 32a.i. related to the DSH calculations and distribution formula.

- Affects Hospitals that participate in the Disproportionate Share Hospital (DSH) program.
- Allows the State to modify the calculations and distribution of DSH funds when necessary.
- Allows the Division to enter into an agreement with the Hospitals to calculate and distribute available DSH funds.
- Outlines the percentages used to calculate and determine the distribution of DSH funds.
- The total amount distributed to an individual hospital may not, under any circumstance, exceed the total uncompensated care costs (DSH limit) for that facility, therefore, the Division may opt to reduce the DSH allotment accordingly to prevent overpayments withing the year.

The effective date of change is 2/21/2023 and expires by 11/1/2023.
