### Introduction:

Casey Angres, Chief of Division Compliance, DHCFP, opened the Public Hearing introducing herself, Malinda Southard, Deputy Administrator, DHCFP, and Gabriel Lither, Senior Deputy Attorney General.

Casey Angres – The notice for this public hearing was published on July 27, 2023, and revised on August 3, 2023, and August 22, 2023, in accordance with Nevada Statute 422.2369.

#### 2. Discussion of Amendments to the State Plan for Medicaid Services and Solicitation of Public Comments

## Subject: Attachment 4.19-B, Specialty Physician Administered Drugs (PAD)

David Olsen, Chief of Pharmacy Services, DHCFP presented the proposed amendment to the Nevada State Plan---Attachment 4.19-B. This amendment will incorporate the Medicare Part B fee schedule as a means to reimburse for outpatient drugs administered by a health care provider; billed as a professional claim, commonly known as PAD.

Prior to July 1, 2023, Nevada Medicaid has not used fee schedules to pay for outpatient drugs and only relied on an algorithm using a lesser of logic to reimburse providers for the cost of outpatient drugs. One fee schedule went into effect as part of the lesser of logic on July 1, 2023. The Medicare Part B fee schedule, which is published by CMS, will be the second fee schedule used as part of a simplified lesser of logic exclusive to PAD reimbursement.

Proposed policy changes were discussed at the public workshop conducted on June 13, 2023.

Providers who prescribe, dispense, or administer specialty drugs may be affected by this change, including but not limited to the listed provider types (PT) on the agenda. Those not impacted are providers for Federally Qualified Health Centers, Rural Health Clinics, or other providers which are reimbursed based on an encounter rate. Their reimbursement is not being changed.

There are no discernable changes to annual aggregate expenditures.

The effective date of the change is December 1, 2023, subject to CMS Approval.

3. Discussion of proposed Amendments to the State Plan for Medicaid Services and solicitation of public comments

Subject: Attachment 4.19-A, Payment for Inpatient Hospital Services Assurances and Related Information

Lynnette Aaron, Administrative Services Officer for the Fiscal Services Unit, DHCFP, presented DHCFP intends to submit a Medicaid SPA in order to implement a new inpatient fee-for-service (FFS) upper payment limit (UPL) supplemental payment to all qualifying private hospitals in the state of Nevada. These changes are reflected in Nevada Medicaid's State Plan Attachment 4.19-A, Page 33b. The payments for this new program will be determined on an annual basis and disbursed quarterly. For purposes of calculating the supplemental payments, private hospitals will be subdivided into five classes of hospitals: freestanding psychiatric hospitals, rehabilitation hospitals, Long Term Acute Care hospitals (LTACs), Short Term Acute Care hospitals (STACs), and Critical Access Hospitals (CAHs). Data from the state's most recent UPL demonstration to Centers for Medicare and Medicaid Services (CMS) and trended to the payment year, will be used as the estimate for the UPL. There are two payment methodologies: one for Psych, Rehab, LTACs, CAHs. These hospitals will receive a payment equal to its contribution to the aggregate difference between Medicaid payments and the UPL for that class of hospitals. The second methodology is for STACs. Hospitals within this class will receive a payment based on their portion of total FFS paid Medicaid days provided by all STACs.

As part of establishing this program, the Division held stakeholder workshops and meetings in order to gather and evaluate feedback for providing an equitable outcome for all the hospitals.

These changes are expected to increase the annual aggregate expenditures in State Fiscal Year (SFY) 2024 and 2025 by \$71,635,852.

The effective date of this change is July 1, 2023.

4. Discussion of proposed Amendments to the State Plan for Medicaid Services and solicitation of public comments

## Subject: Attachment 4.19-B, Outpatient Hospital Services Assurances and Related Information

Lynnette Aaron, Administrative Services Officer for the Fiscal Services Unit, DHCFP, presented DHCFP intends to submit a Medicaid SPA in order to implement a new outpatient fee-for-service (FFS) upper payment limit (UPL) supplemental payment to all qualifying private hospitals in the State of Nevada. These changes are reflected in Nevada Medicaid's State Plan Attachment 4.19-B, Page 20a.

The payments for this new program will be determined on an annual basis and disbursed quarterly. For purposes of calculating the supplemental payments, hospitals will receive a payment based on their portion of total number of Medicaid claims paid for outpatient FFS for all non-CAH private hospitals. CAHs will receive a weighted payment with a factor of 2.3 applied to their claims, and Sole Community Hospitals will receive a weighted payment with a factor of 1.15 applied to their claims.

Data from the state's most recent UPL demonstration to CMS and trended to the payment year, will be used as the estimate for the UPL.

These changes are expected to increase the annual aggregate expenditures in SFY 2024 and 2025 by \$63,694,270.

The effective date of this change is July 1, 2023.

At the conclusion of Lynnette Aaron's presentation, Casey Angres asked Malinda Southard and Gabriel Lither if they had any questions or comments, they had none.
