- 2. Discussion of proposed Amendments to the State Plan for Medicaid Services and solicitation of public comments

Subject: State Plan for Medicaid Services – Dental Rate Increase

DHCFP is proposing revisions to the Nevada Medicaid State Plan, Attachment 4.19-B, Page 2c. As a result of funding appropriations allocated by Senate Bill (SB) 504 of the 2023 Legislative Session, a 5% rate increase will be implemented for Dental Services.

This State Plan Amendment (SPA) is anticipated to impact Medicaid enrolled providers delivering dental type services including but not limited to provider types (PT): Dental (PT 22) and Physician M.D. (PT 20).

Estimated change in annual aggregate expenditures: An estimated increase in annual aggregate expenditures for state fiscal year (SFY):

SFY 20232024: \$2,485,081 SFY 20242025: \$4,970,797

The effective date of change is January 1, 2024.

- 3. Discussion of proposed Amendments to the State Plan for Medicaid Services and solicitation of public comments

Subject: Home Health Services (Including Private Duty Nursing), Attachment 4.19-B, Page 2 and 2a

DHCFP intends to increase current rates by 15% for Home Health Services including Private Duty Nursing (PDN) per the legislatively approved State Budget for fiscal years (FY) 24 & 25.

This SPA is anticipated to impact all Medicaid enrolled providers delivering Home Health Services, including Private Duty Nursing (PT 29). This is an opportunity to call this regulation to the attention of providers which may be affected, even if is presumed that there will be no negative financial impact to them.

Estimated change in annual aggregate expenditures:

SFY 2024: \$2,124,482 SFY 2025: \$4,593,465

The effective date of change is January 1, 2024.

- 4. Discussion of proposed Amendments to the State Plan for Medicaid Services and solicitation of public comments

Subject: Payment for Long Term Nursing Facility Services Methods and Standards

As a result of funding appropriations allocated by SB 504 and Assembly Bill (AB) 237 of the 2023 Nevada Legislative Session, the Division is proposing a SPA to implement a 24.5% increase for Nursing Facility (NF) rates. The increase applies to the weighted neutral per diem rate, the ventilator dependent add-on rate, and Pediatric Levels I and II rates. Section 4.19-D, Pages 5i and 9 of the State Plan will be updated to reflect this change.

This SPA is anticipated to impact Medicaid NFs Providers (PT 19).

Estimated change in annual aggregate expenditures: An estimated increase in annual aggregate expenditures:

SFY 2024: \$18,178,876 SFY 2025: \$43,881,757

The effective date of change is January 1, 2024.

- 5. Discussion of proposed Amendments to the State Plan for Medicaid Services and solicitation of public comments

Subject: Personal Care Services Rate Increase with Wage Requirement

The Division intends to submit a SPA to increase the reimbursement rates for Personal Care Services (HCPCS Code T1019) by 42.37%, resulting in an hourly rate equivalent to \$25 per hour. This rate change was included in the legislatively approved DHCFP budget for FY 24-25 based on recommendations from the Nevada Home Care Employment Standards Board. This SPA also includes a new requirement that at least \$16 of the total \$25 per hour rate be passed directly to the individual rendering the servicedirect care home workers (employed and/or contracted) be paid a minimum hourly wage of \$16.00 per hour as a condition of receiving the \$25.00 per hour rate for Personal Care Services.. Section 4.19-B, Page 4 (Addendum) of the State Plan will be updated to reflect this change.

This SPA is anticipated to impact Medicaid enrolled providers delivering Personal Care Services (PT 30 and 83).

Estimated change in annual aggregate expenditures:

SFY 2024: \$23,349,042 SFY 2025: \$51,840,260 The effective date of change is January 1, 2024.

- 6. Discussion of proposed Amendments to the State Plan for Medicaid Services and solicitation of public comments

A. Subject: 5% Rate Increase for Physicians

The Division is proposing an amendment to the Nevada Medicaid State Plan, Attachment 4.19-B, Pages 1c and 1c (continued). During the 2023 Nevada Legislative Session, SB 504 was passed and signed into law; this bill authorized a 5% increase for physicians, including anesthesia services rendered by a physician.

This SPA is anticipated to impact Medicaid enrolled providers providing Physician Services (PT 20).

Estimated change in annual aggregate expenditures: An estimated increase in annual aggregate expenditures:

SFY 2024: \$18,692,171 SFY 2025: \$36,994,490

The effective date of this change is January 1, 2024.

B. Subject: Payments for Advanced Practice Registered Nurses and Certified Nurse Midwives in Parity with Physicians

The Division is proposing an amendment to the Nevada Medicaid State Plan Attachment 4.19-B, Pages 1d (continued) and 1e (continued). During the 2023 Nevada Legislative Session, SB 504 was passed and signed into law; this bill authorized the Division to pay advanced practice registered nurses (APRN) and certified nurse midwives in parity with physicians. Rates paid in parity will be adjusted to include both the pediatric enhancement allowable for some physician services as well as the 5% rate increase for physicians effective January 1, 2024.

This SPA is anticipated to impact Advanced Practice Registered Nurse (PT 24) and Certified Nurse Midwife (PT 74).

Estimated change in annual aggregate expenditures: An estimated increase in annual aggregate expenditures:

SFY 2024: \$11,805,906 SFY 2025: \$24,772,092

The effective date of this change is January 1, 2024.

C. Subject: Payments for Physician Assistants in Parity with Physicians Under Certain Circumstances

The Division is proposing an amendment to the Nevada Medicaid State Plan Attachment 4.19-B, Pages 1d (continued) and 1e (continued). During the 2023 Nevada Legislative Session, SB 439 was passed and signed into law. Per the terms of this bill, the Nevada Medicaid State Plan must be updated to allow APRNs and physician

assistants (PAs) to be paid in parity with physicians when providing services to test for, treat, or prevent human immunodeficiency virus or hepatitis C. Please note that although APRNs are included in SB 439 under specific circumstances, full parity for APRNs was included in SB 504 of the 2023 Nevada Legislative Session; as such, this agenda item only addresses parity for PAs under the conditions described in the bill.

This SPA is anticipated to impact Physician Assistants (PT 77).

Estimated change in annual aggregate expenditures: An estimated increase in annual aggregate expenditures:

SFY 2024: \$4,925 SFY 2025: \$10,523

The effective date of this change is January 1, 2024.

D. Subject: Changes to Types of Practitioners Permitted to Supervise a Community Health Worker

The Division is proposing an amendment to the Nevada Medicaid State Plan Attachment 4.19-B, Pages 1b, 1b(b), 1c, 1c (continued), 1d (continued), 1e (continued) and 1e (continued p1). During the 2023 Legislative Session, SB 117 was passed and signed into law. This bill allows additional types of practitioners to supervise a community health worker (CHW). Changes made to the State Plan pages mentioned above remove the CHW reimbursement methodology from being placed only under the State Plan sections for physicians and advanced practice registered/physician assistants and instead creates a distinct section for the CHW reimbursement methodology. The intent of this change is to ensure that the Division has federal authority to reimburse the services of a CHW supervised by other types of practitioners in addition to physicians, APRNs, and PAs. There are no anticipated changes to the reimbursement rates currently paid to CHWs; the fiscal impact amounts listed below reflect only the anticipated increase in the number of CHW services provided to Medicaid recipients.

This SPA is anticipated to impact Community Health Workers (PT 89).

Estimated change in annual aggregate expenditures: An estimated increase in annual aggregate expenditures:

SFY 2024: \$10,323 SFY 2025: \$21,067

The effective date of this change is January 1, 2024.

- 7. Discussion of proposed Amendments to the State Plan for Medicaid Services and solicitation of public comments

Subject: FMAP changes to the Nursing Facility Supplemental Payments.

As a result of funding appropriations allocated by SB 504 the calculation of the Federal Medical Assistance Percentages (FMAP) applied to the NF Supplemental Payment will be expanded to include FMAP calculations from 42 CFR 433.10 (c). Total spent on NF days and the aid code of the members from the base quarter will be gathered

to calculate a weighted state share percentage. Section 4.19-D Page 10a of the State Plan will be updated to reflect this change.

This SPA is anticipated to impact Nursing Facilities Providers (PT 19).

Estimated change in annual aggregate expenditures: An estimated increase in annual aggregate expenditures:

SFY 2024: \$4,017,086 SFY 2025: \$8,113,739

Please note that no State General Fund Dollars are used to increase aggregate expenditures.

The effective date of change is January 1, 2024.
