1. On February 14, 2013, the Federal Department of Education posted a final rule on the Federal Register (Vol. 78, No. 31) changing 34 CFR, Part 300. The rule modifies “parental consent” language for special education services provided to children under the Individuals with Disabilities and Education Act (IDEA). Additionally, we will discuss third party liability (other health insurance) and utilization management criteria for School Based Child Health Services.

The purpose of this workshop is to explore possible updates and subsequently propose new language to Medicaid Services Manual (MSM) chapter 2800 (School Based Child Health Service):

- a. Parental consent for schools to bill DHCFP for Individualized Education Program (IEP) services provided to Medicaid and Nevada Check Up recipients,
  - b. Guidelines regarding private insurance and third party liability, and
  - c. Utilization management for School Based Child Health Services.
