 - a. **The purpose of this workshop is to obtain public input in the proposed revisions to the Katie Beckett Eligibility Option policy. The proposed revisions incorporate guidelines regarding parental responsibility when assessing a child for nursing facility Level of Care (LOC). LOC determinations for children must include an age appropriate assessment of a child's functional ability in relation to developmental milestones of similar aged children. This revision includes additional definitions which will assist in the assessment of children for LOC.**

The chapter revision does not affect eligibility or Maintenance of Effort (MOE) for the Katie Beckett Eligibility Option.
