**MSM Chapter 200, Inpatient Hospital Services, will be revised to include an AUTHORIZATION section heading and to relocate and reorganize authorization policy under this heading. Policy will be added to clarify prior authorization requirements or to extend provider authorization submission timeframes related to specific types of inpatient admissions. Policy will be added regarding authorization requirements for outpatient hospital and freestanding facility services. Authorities will be added and corrected. The Long Term Acute Care and Inpatient Rehabilitation policies will be clarified. MSM Chapter 200, Attachment A Policy #02-04, Hospitals with Swing Beds, will be retitled, reformatted and moved to Section 203.3.**
