Nursing Facility Provider Fee - Proposal to Allow "Pending Medicaid" Days to be counted as Medicaid Days

Current program guidelines do not permit a Skilled Nursing Facility (SNF) to county Pending Medicaid Days as Medicaid days in the Provider Fee and Supplemental Payment Program. The Medicaid Operations Manual (MOM) Chapter 1100, Section 1102 states: "Medicaid patient days are days when a nursing facility resident occupies a bed and Medicaid pays all or any part of the nursing facility charges, unless Medicare pays a portion of the charges. If Medicare pays all or any part of the nursing facility charges for the patient day, the day is excluded from Medicaid patient days and counted in Medicare patient days. Medicaid patient days do not include patients whose Medicaid application is pending."

The Division of Health Care Financing and Policy (DHCFP) was asked to evaluate the program impact if facilities were allowed to include "Pending Medicaid Days as Medicaid in the program calculations of State Fiscal Year (SFY) Quarters 1 and 2.

To estimate the impact, the DHCFP:

- 1 Revised the SFY 2019 Q1 & Q2 SNF Provider Fee Quarterly Calculations by moving all Pending Medicaid Days reported into the Medicaid Days Column. This change means all the Pending Medicaid days are now being included in the Medicaid Occupancy calculation as well as the Supplemental Payment Calculations.
- 2 DHCFP recalculated the quarter rates based on the revised number of days at each rate to meet the minimum statistical requirements set by federal regulation.
- 3 The resulting revised fee rates by quarter are below:
