Changes and amendments include: the Aging and Disability Services Division (ADSD) assumed duties as the operating agency July 1, 2015; the State is consolidating the review process with other services; there is a new focus on person centered planning; there is an allowance for different methods of signature on program documents; recipients may self direct attendant care, chore, respite and homemaker services; another level of priority has been added to the waitlist based upon the assessed level of need; the new rules for HCBS have been addressed; and the DHCFP will accept the training and monitoring of training for personal care attendants that is required by the Department of Public and Behavioral Health (DPBH) as sufficient.
