- <u>Attachment 4.19-B, Page 1d (continued)</u>: Payment for medical nutrition therapy services billed by a Registered Dietician will be calculated using the January 1, 2014 unit values for the Nevada specific resource based relative value scale (RBRVS) and the 2014 Medicare Physicians Fee Schedule conversion factor. Payment for medicine codes 90000 – 99199 will be reimbursed at 63% of the Medicare non-facility rate.
