authorization requirements for emergency inpatient services. The intent is to allow for five business days instead of one business day for emergency inpatient admissions, transfers and changes in level of care that require authorization.

- b. MSM Chapter 200 – Sections 203.1(B)(7)(f)(1) and (2) – Proposed update to allow Critical Access Hospitals (CAH) to submit separate claims for outpatient observation, ancillary services and emergency department services when the patient is admitted into inpatient.
 - c. MSM Chapter 200 – Sections 203.1(B)(8)(a) and (b) – Proposed update to add language regarding exceptions to the authorization requirement listed in agenda Item #b.
 - d. MSM Chapter 200 – Section 203.1 – Proposed updates throughout the chapter to assist in clarifying elective vs. medically necessary cesareans.
 - e. MSM Chapter 200 – Section 203.1(B) – Proposed update to remove patient liability requirements from hospital policy.
 - f. MSM Chapter 200 – Attachment A, Policy # 02-02 – Proposed update to remove the FA 100 – Initial Emergency Dialysis Case Certification Form requirement.
 - g. MSM Chapter 200 – Proposed updates for clarifications, grammatical, punctuational and numerical changes throughout the chapter.
