Nevada begins its Ex Parte renewal process starting 75 days prior to the end of the annual Medicaid period. If Ex parte fails, a paper renewal packet is then generated and mailed to the household on Day 60. Households have until the last day of their renewal period to submit a completed renewal packet.
