- a. The purpose of this workshop for BCI is to inform the stakeholders of the newly established rate and encourage feedback. The Division of Health Care Financing and Policy (DHCFP) is in the process of establishing a rate to care for individuals who exhibit complex behavioral episodes. The intention of this rate is to incentivize in-state providers to provide care, rather than sending Medicaid recipients with medically-based behavior disorders out-of-state for care.

The enhanced rate to care for BCI may be approved for those recipients exhibiting extreme, unpredictable aggression; recipients who have been treated for their severe medically-based behavior disorder or other medical conditions across multiple medical, institutional and/or correctional environments with little or no success; or recipients exhibiting behaviors extremely disruptive or dangerous to themselves, other recipients or Nursing Facility staff.
