The Division of Health Care Financing and Policy (DHCFP) is amending the 1915(c) Home and Community Based Services (HCBS) Waivers for the Frail Elderly (FE) and Persons with Physical Disabilities (PD). A March 2023 cost study recommended increasing the current rate for Home Delivered Meals (HDM) service rendered by Provider Type 58, Specialty Code 204. The proposed rate would increase by 100% from \$5 to \$10 a meal and would have an effective date of October 21, 2024, or upon receipt of approval from the Centers for Medicare and Medicaid Services (CMS), whichever comes later.
