

Statewide Managed Care Questions & Answers

September 2025

Background

Starting January 1, 2026, Nevada Medicaid is rolling out managed care statewide, including in rural areas for the first time. Here are the plans to choose from in your area:

- All rural areas (including rural Washoe & Clark Counties): CareSource, Silver Summit.
- **Urban Clark County:** Anthem, CareSource, Health Plan of Nevada, Molina, Silver Summit.
- Urban Washoe County: Anthem, CareSource, Molina, Silver Summit.

Ask your doctors, providers, and pharmacies which plan they are with. These changes will improve health care in rural Nevada. Be sure to look for a letter in the mail about the change starting in October. Don't miss the letter. Update your address with this form:



Update your address

1. What is changing?

Rural Nevadans can pick from two managed care health plans: CareSource and SilverSummit. Health care is expected to improve in rural Nevada.

In a 2024 survey, Medicaid members asked for:

- more preventive health;
- easier appointments;
- more doctors & providers.

We Listened. Managed care health plans will:

- focus on preventive health by offering incentives for those services.
- be held accountable for meeting appointment standards.
- bring more doctors & providers to rural Nevada.
- offer free extra benefits.

2. What are Managed Care health plans?

Managed Care health plans have teams of doctors and providers. If you are a Nevada Medicaid and Nevada Check Up member, you will get almost all of your covered services through the plan you pick.

3. Can I change plans?

You will be placed with a health plan in 2026. You have 90 days from your enrollment date to change plans. Use the health plan change form (English) . You can request a form from Medicaid@nvha.nv.gov

4. How will you be notified if you have a new health plan?

You will get a letter in the mail in October 2025 if you are going to get benefits from a health plan. The letter will have details and instructions. Be sure to update your mailing address and contact information. To update your address, see the attached "Medicaid Members: Update your address to keep your coverage."

5. Which health plans will be available in my area and how do I contact them?

6. Can I request not to be moved into a health plan?

No. Only these members will not be switched:

Aged, blind, or disabled People with certain disabilities

Children in foster care Katie Beckett members

Youth in juvenile justice systems People in home & community-based waivers

Members 65 and older

7. What benefits do managed care health plans have?

All health plans have the same basic benefits. They also have different <u>free extra benefits</u>. Links to free extra benefits from each plan are available on the web page at the QR code below. CareSource information will be added on 10/1/2025.



8. How do you know if your doctor is part of your new health plan?

Ask your doctor which plan they are with, or ask health plans if your doctor is with them.

9. Will transportation be affected?

Health plans will arrange travel for you. Contact them to discuss your needs.

10. Will dental coverage change?

No. Dental benefits for rural Nevadans will stay under fee for service. Urban areas will continue to receive benefits through Liberty Dental.

11. Will you get a new Medicaid ID Card?

Your new health plan may send you a member card with instructions. Don't throw away your Nevada Medicaid ID Card. It will always be valid even if you change health plans.



A partir del 1 de enero de 2026, Medicaid de Nevada pondrá en marcha la atención médica gestionada con cinco planes de salud. Estos son los planes entre los que podrá elegir en su zona:

- Todas las zonas rurales (incluidos los condados de Washoe y Clark):
 CareSource y SilverSummit.
- Condado Urbano de Clark: Anthem, CareSource, Health Plan of Nevada, Molina y SilverSummit.





