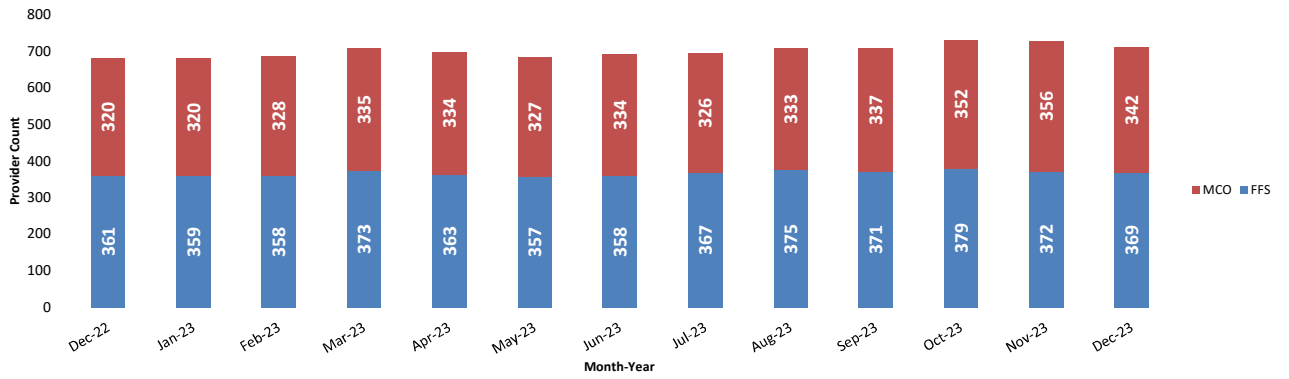

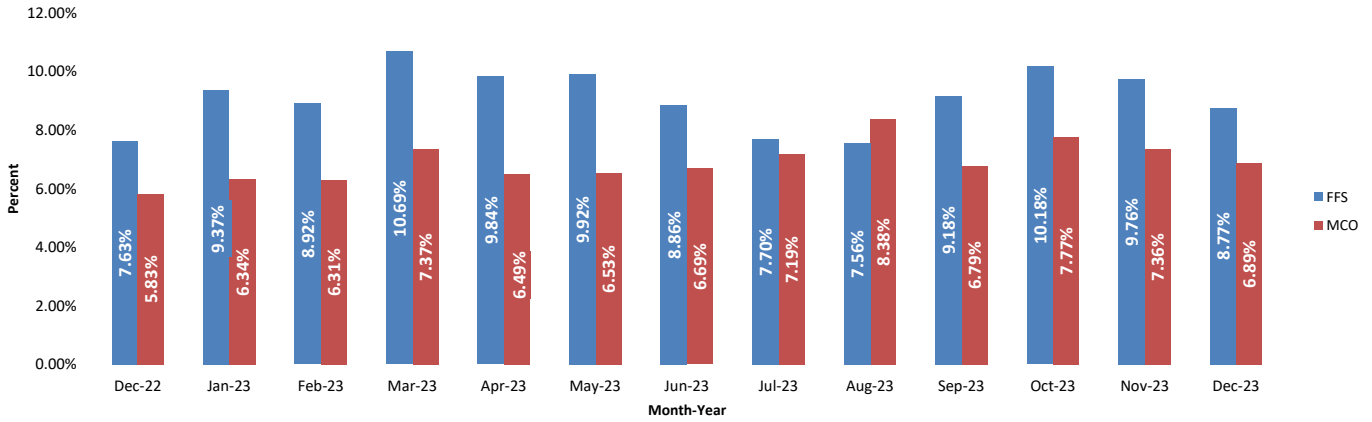

Medicaid Data

The Division of Health Care Financing and Policy (DHCFP) data warehouse is comprised of claims data submitted by over 35,000 Medicaid providers from within Nevada and across the country. While DHCFP staff conscientiously make every effort to validate these data through continuous provider education and the use of highly experienced audit staff, the Division relies heavily on providers to submit accurate and complete information on Medicaid patients. It should therefore be understood by the users of DHCFP reports on disease morbidity and patient health that the data source for these reports are based solely on patient claims data and may not be a complete and comprehensive health record.

Fee For Service (FFS) provider data are gathered from the Nevada Medicaid Data Warehouse Decision Support System (DSS). The DSS provides monthly updates gathered from the Centers for Medicare & Medicaid Services (CMS) Transformed Medicaid Statistical Information System (T-MSIS). Alternatively, Liberty Dental (LD) data are provided by the Managed Care Organization (MCO) directly on a monthly basis.

MCO expenditures are not State expenditures, but costs incurred by the MCOs when paying their respective providers.

Methodology

All reports are in incurred mode, based on date of service.

D1000 thru D1999 Preventive

D2000 thru D2999 Restorative

D3000 thru D3999 Endodontics

D4000 thru D4999 Periodontics

D5000 thru D5899 Prosthodontics

D5900 thru D5999 Maxillofacial

D6000 thru D6199 Implant Services

D6200 thru D6999 Prosthodontics

D7000 thru D7999 Oral and Maxillofacial

D8000 thru D8999 Orthodontics

D9000 thru D9999 Adjunctive

The enrollee's age in years at the time of service has been used to define age grouping reported in this analysis.

FFS net payments have been provided in this analysis. Net payments are defined as the net amounts paid for all claims, after all pricing guidelines have been applied, and all third party, copayment, coinsurance and deductible amounts have been subtracted.

Decreases in counts of services, patients and net payments after March 2020 are due to COVID-19 pandemic response.

Section 1 Enrolled Dental Providers

Reported by DSS via the provider enrollment file updated monthly by IBM.

Providers are unduplicated, may provide services to both the FFS and MCO populations, and may have servicing addresses in another state.

Section 2 Active Dental Providers

Reported by DSS (FFS) and Liberty Dental (8101 Dental Report - Provider) Unduplicated.

FFS: Dentists (PT22) are counted if they had at least one paid claim for the respective services month and include those with servicing addresses in another state.

LD: Monthly services report.

Section 3

Reported by DSS (FFS) and Liberty Dental (8102 Dental Report - Patient).

FFS: Unduplicated Dental patients (PT22) are counted if they had at least one paid claim for the respective services month.

LD: Monthly services report.

Sections 4 & 5 Service Count and Costs (SC&C)

Reported by DSS (FFS Section 4) and Liberty Dental (Section 5).

Liberty Dental Report is the 8103 Dental Report - Service Count and Costs.

Liberty Dental expenditures are made to their providers on behalf of the State, and are not State expenditures.

Section 6 Members (FFS + Liberty Dental Capitation Payments - Per DSS)

Fee for Service Member Count. Each member is counted once regardless of their number of eligible months.

Liberty Capitation Payments from the monthly financial file from Gainwell.

One capitation payment = one Liberty Dental enrollee.

Section 7 Percent of Enrollees Receiving Services

Compares services to FFS enrollment or number of Liberty Dental capitation payments.
