Dear Tribal Members:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed updates to the State Plan:

DHCFP is proposing revisions to the Nevada Medicaid State Plan, Attachment 4.19-A, page 31d. The Amendment will add two new programs of managed care inpatient and outpatient indirect graduate medical education (IME) for certain hospitals.

This State Plan Amendment (SPA) is anticipated to impact certain hospitals that are Medicaid enrolled providers delivering inpatient and outpatient services in managed care.

Estimated change in aggregate inpatient expenditures: An estimated increase in annual aggregate expenditures for state fiscal year (SFY):

SFY 2025: \$17,903,241

SFY 2026: \$18,440,338

Estimated change in aggregate outpatient expenditures: An estimated increase in annual aggregate expenditures for state fiscal year (SFY):

SFY 2025: \$18,446,047

SFY 2026: \$18,999,428

The effective date of change is July 1, 2024 and there is no anticipated fiscal impact to Tribal Governments.
