Dear Tribal Members:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed change in policy:

Revisions are being proposed to the Medicaid Service Manual (MSM) Chapter 4100 – Substance Use Disorder (SUD) Treatment Coverage and Services, to align service language in policy to that in the state plan. Revisions were made to provide clarification of covered services in the American Society of Addiction Medicine (ASAM) Criteria Level 1; to align language for prior authorization to include the need for medical necessity; to replace “patient” with “recipient” throughout the chapter; and to add a citation to the Code of Federal Regulations (CFR) 42 part 8 in the Opioid Treatment Program policy when needed. Additionally, Clinical Social Work Interns, Marriage and Family Therapy Interns and Clinical Professional Counselor Interns were added to the list of individuals who can perform substance use disorder (SUD) treatment. Supervision requirements were updated to align Medicaid policy with that to the respective licensing board. Lastly Partial Hospitalization Program (PHP) requirements were updated to remove the need for a provider to contract with a hospital as a provider of this level is Substance Abuse and Prevention Treatment Agency (SAPTA) certified through the Division of Public Behavioral Health (DPBH) to ensure appropriateness to provide this level of care.

Throughout the chapter, grammar, punctuation and capitalization changes were made, duplications were removed, acronyms were used and standardized, and language was reworded for clarity. Renumbering and re-arranging of sections was necessary.

There is no anticipated fiscal impact to Tribal Governments.
