Dear Tribal Members:

In accordance with established consultation guidelines, the Nevada Health Authority (NVHA) is notifying Nevada tribes of the following proposed policy:

Revisions to Medicaid Service Manual (MSM) Chapter 4100—Substance Use Disorder Treatment Services and Coverage are being proposed to add Nevada Administrative Code (NAC) 458: Abuse of Alcohol and Drugs, to the list of authorities as this authority allows Nevada Medicaid to align policy to Division of Public and Behavioral Health (DPBH) criteria. In MSM Section 4114, Provider Requirements, new language was added that requires providers with more than one geographical location for treatment services to enroll each geographical location with Nevada Medicaid, have a separate National Provider Identification (NPI) for each geographical location, certify each geographical location through DPBH, and report changes in the certification to Nevada Medicaid in pursuant to MSM chapter 100—Medicaid Program. Lastly, in alignment with the implementation plan of Nevada's Treatment of Opioid Use Disorders (OUDs) and Substance Use Disorders (SUDs) Transformation Project, commonly known as the 1115 SUD waiver, language is being added that requires providers to participate in a centralized bed registry.

There is no anticipated fiscal impact to Tribal Government.
