Dear Tribal Members:

In accordance with established consultation guidelines, the Division of Health Care Financing and Policy (DHCFP) is notifying Nevada tribes of the following proposed changes to the Nevada Medicaid State Plan:

The Division of Healthcare Finance and Policy is proposing an Amendment to the Nevada Medicaid State Plan (SPA), Attachment 4.19-B, Pages 1e-1e (Con't), 2b-2b (Con't), 3b-3k and 18-18f to amend the reimbursement rates for Provider Type 14 – Behavioral Health Outpatient Treatment, Provider Type 17-215 – Substance Abuse Agency Model (SAAM), Provider Type 26 – Psychologist, Provider Type 82 – Rehabilitative Behavioral Health, Provider Type 86 – Specialized Foster Care and, Provider Type 93 – Substance Use Treatment. Under the proposed change, the existing reimbursement methodology would be amended to include a rate increase based on a Consumer Price Index (CPI) adjustment factor from the date of last rate update for each CPT code or to the current Medicare per diem rate. In addition, funding was included for the setup of a Family Peer Support Services for children. The changes to the methodology will result in an average of a 30% increase to all provider codes indicated on the published fee schedule.
