Dear Tribal Members:

In accordance with established consultation guidelines, the Nevada Health Authority (NVHA) is notifying Nevada tribes of the following proposed changes to the Nevada Medicaid State Plan:

The NVHA is submitting a State Plan Amendment (SPA) to update Section 1.1 of the State Plan for Medicaid to reflect a change in the Single State Agency (SSA) for Medicaid from the Department of Health and Human Services (DHHS) to the NVHA. <u>Senate Bill (SB) 494</u> passed during the 83rd (2025) Legislative Session reorganizes and renames the DHHS to the Department of Human Services (DHS), and establishes the NVHA, which is now the Department that holds authority over and administers the state's Medicaid programs.

Under SB494, the Division of Health Care Financing and Policy (DHCFP) is abolished, and the Division of Nevada Medicaid has been created within the NVHA. Most of the duties related to the administration of the former DHCFP have been transferred to the Division of Nevada Medicaid.

The effective date of this SPA is July 1, 2025.
