The Medicaid Home and Community-Based Services (HCBS) waiver program is authorized in §1915(c) of the Social Security Act. The program permits a state to furnish an array of home and community-based services that assist Medicaid beneficiaries to live in the community and avoid institutionalization. The State has broad discretion to design its waiver program to address the needs of the waivers target population. Waiver services complement and/or supplement the services that are available to participants through the Medicaid State plan and other federal, state and local public programs as well as the supports that families and communities provide.

The Centers for Medicare & Medicaid Services (CMS) recognizes that the design and operational features of a waiver program will vary depending on the specific needs of the target population, the resources available to the state, service delivery system structure, state goals and objectives, and other factors. A State has the latitude to design a waiver program that is cost-effective and employs a variety of service delivery approaches, including participant direction of services.

2. Brief Waiver Description

Brief Waiver Description. *In one page or less*, briefly describe the purpose of the waiver, including its goals, objectives, organizational structure (e.g., the roles of state, local and other entities), and service delivery methods.

The Division of Health Care Financing and Policy (DHCFP) currently administers the Home and Community Based Waiver for the Frail Elderly (FE), a Medicaid Home and Community-Based Services waiver under the authority of Section 1915(c) of the Social Security Act. The provision of waiver services is based on the identified needs of the waiver recipient. Nevada is committed to the goal of providing the elderly with the opportunity to remain in a community setting in lieu of institutionalization, with the ultimate goals of self sufficiency and independence. This waiver has been in existence since July of 1992.

Aging and Disability Services Division (ADSD) operates the waiver, which includes data collection for eligibility verification, evaluation of Level of Care (LOC), Plan of Care (POC) development, and annual reassessments. The DHCFP exercises administrative authority over the operation of the waiver and issues policies, rules, and regulations related to the waiver.

The purpose of this waiver is to offer the option of Home and Community Based Services (HCBS) as an alternative to nursing facility care. Access to the services available in the waiver is voluntary and no individual is required to leave a nursing facility. The target population are individuals who are age 65 and older, has a need for at least one (1) waiver service, meet a Nursing Facility (NF) Level of Care (LOC) and financial income criteria.

Eligible applicants may be placed from an institution, another waiver program, or the community. An evaluation will be made to support that there is a reasonable indication that recipient would need nursing home services in the near future (30 days or less) unless he or she receives home and community based services, the cost of which would be reimbursed under the approved waiver.

The following services are included in this waiver: Case management, Homemaker, Respite care, Chore services, Personal Emergency Response Systems, Companion services, Adult Day Care, and Augmented Personal Care. Services will be provided in accordance with this waiver and by qualified Medicaid providers who have enrolled through DHCFP's fiscal agent.

3. Components of the Waiver Request

The waiver application consists of the following components. Note: <u>Item 3-E must be completed.</u>

- **A.** Waiver Administration and Operation. Appendix A specifies the administrative and operational structure of this waiver.
- **B.** Participant Access and Eligibility. Appendix B specifies the target group(s) of individuals who are served in this waiver, the number of participants that the state expects to serve during each year that the waiver is in effect, applicable Medicaid eligibility and post-eligibility (if applicable) requirements, and procedures for the evaluation and reevaluation of level of care.

5. Assurances

In accordance with 42 CFR §441.302, the state provides the following assurances to CMS:

- **A. Health & Welfare:** The state assures that necessary safeguards have been taken to protect the health and welfare of persons receiving services under this waiver. These safeguards include:
 - 1. As specified in Appendix C, adequate standards for all types of providers that provide services under this waiver;
 - 2. Assurance that the standards of any state licensure or certification requirements specified in **Appendix C** are met for services or for individuals furnishing services that are provided under the waiver. The state assures that these requirements are met on the date that the services are furnished; and,
 - **3.** Assurance that all facilities subject to §1616(e) of the Act where home and community-based waiver services are provided comply with the applicable state standards for board and care facilities as specified in **Appendix C**.
- **B. Financial Accountability.** The state assures financial accountability for funds expended for home and community-based services and maintains and makes available to the Department of Health and Human Services (including the Office of the Inspector General), the Comptroller General, or other designees, appropriate financial records documenting the cost of services provided under the waiver. Methods of financial accountability are specified in **Appendix I**.
- **C. Evaluation of Need:** The state assures that it provides for an initial evaluation (and periodic reevaluations, at least annually) of the need for a level of care specified for this waiver, when there is a reasonable indication that an individual might need such services in the near future (one month or less) but for the receipt of home and community-based services under this waiver. The procedures for evaluation and reevaluation of level of care are specified in **Appendix B**.
- **D.** Choice of Alternatives: The state assures that when an individual is determined to be likely to require the level of care specified for this waiver and is in a target group specified in **Appendix B**, the individual (or, legal representative, if applicable) is:
 - 1. Informed of any feasible alternatives under the waiver; and,
 - 2. Given the choice of either institutional or home and community-based waiver services. Appendix B specifies the procedures that the state employs to ensure that individuals are informed of feasible alternatives under the waiver and given the choice of institutional or home and community-based waiver services.
- **E.** Average Per Capita Expenditures: The state assures that, for any year that the waiver is in effect, the average per capita expenditures under the waiver will not exceed 100 percent of the average per capita expenditures that would have been made under the Medicaid state plan for the level(s) of care specified for this waiver had the waiver not been granted. Costneutrality is demonstrated in **Appendix J**.
- **F. Actual Total Expenditures:** The state assures that the actual total expenditures for home and community-based waiver and other Medicaid services and its claim for FFP in expenditures for the services provided to individuals under the waiver will not, in any year of the waiver period, exceed 100 percent of the amount that would be incurred in the absence of the waiver by the state's Medicaid program for these individuals in the institutional setting(s) specified for this waiver.
- **G. Institutionalization Absent Waiver:** The state assures that, absent the waiver, individuals served in the waiver would receive the appropriate type of Medicaid-funded institutional care for the level of care specified for this waiver.
- **H. Reporting:** The state assures that annually it will provide CMS with information concerning the impact of the waiver on the type, amount and cost of services provided under the Medicaid state plan and on the health and welfare of waiver participants. This information will be consistent with a data collection plan designed by CMS.
- **I. Habilitation Services.** The state assures that prevocational, educational, or supported employment services, or a combination of these services, if provided as habilitation services under the waiver are: (1) not otherwise available to the individual through a local educational agency under the Individuals with Disabilities Education Act (IDEA) or the Rehabilitation Act of 1973; and, (2) furnished as part of expanded habilitation services.
- **J. Services for Individuals with Chronic Mental Illness.** The state assures that federal financial participation (FFP) will not be claimed in expenditures for waiver services including, but not limited to, day treatment or partial hospitalization, psychosocial rehabilitation services, and clinic services provided as home and community-based services to individuals with chronic mental illnesses if these individuals, in the absence of a waiver, would be placed in an IMD and are: (1) age 22 to 64; (2) age 65 and older and the state has not included the optional Medicaid benefit cited in 42 CFR § 440.140; or (3) age 21 and under and the state has not included the optional Medicaid benefit cited in 42 CFR § 440.160.

6. Additional Requirements

Note: Item 6-I must be completed.

- **A. Service Plan.** In accordance with 42 CFR §441.301(b)(1)(i), a participant-centered service plan (of care) is developed for each participant employing the procedures specified in **Appendix D**. All waiver services are furnished pursuant to the service plan. The service plan describes: (a) the waiver services that are furnished to the participant, their projected frequency and the type of provider that furnishes each service and (b) the other services (regardless of funding source, including state plan services) and informal supports that complement waiver services in meeting the needs of the participant. The service plan is subject to the approval of the Medicaid agency. Federal financial participation (FFP) is not claimed for waiver services furnished prior to the development of the service plan or for services that are not included in the service plan.
- **B. Inpatients**. In accordance with 42 CFR §441.301(b)(1)(ii), waiver services are not furnished to individuals who are inpatients of a hospital, nursing facility or ICF/IID.
- **C. Room and Board**. In accordance with 42 CFR §441.310(a)(2), FFP is not claimed for the cost of room and board except when: (a) provided as part of respite services in a facility approved by the state that is not a private residence or (b) claimed as a portion of the rent and food that may be reasonably attributed to an unrelated caregiver who resides in the same household as the participant, as provided in **Appendix I**.
- D. Access to Services. The state does not limit or restrict participant access to waiver services except as provided in Appendix C.
- **E. Free Choice of Provider**. In accordance with 42 CFR §431.151, a participant may select any willing and qualified provider to furnish waiver services included in the service plan unless the state has received approval to limit the number of providers under the provisions of §1915(b) or another provision of the Act.
- **F. FFP Limitation**. In accordance with 42 CFR §433 Subpart D, FFP is not claimed for services when another third-party (e.g., another third party health insurer or other federal or state program) is legally liable and responsible for the provision and payment of the service. FFP also may not be claimed for services that are available without charge, or as free care to the community. Services will not be considered to be without charge, or free care, when (1) the provider establishes a fee schedule for each service available and (2) collects insurance information from all those served (Medicaid, and non-Medicaid), and bills other legally liable third party insurers. Alternatively, if a provider certifies that a particular legally liable third party insurer does not pay for the service(s), the provider may not generate further bills for that insurer for that annual period.
- **G. Fair Hearing:** The state provides the opportunity to request a Fair Hearing under 42 CFR §431 Subpart E, to individuals: (a) who are not given the choice of home and community-based waiver services as an alternative to institutional level of care specified for this waiver; (b) who are denied the service(s) of their choice or the provider(s) of their choice; or (c) whose services are denied, suspended, reduced or terminated. **Appendix F** specifies the state's procedures to provide individuals the opportunity to request a Fair Hearing, including providing notice of action as required in 42 CFR §431.210.
- **H. Quality Improvement**. The state operates a formal, comprehensive system to ensure that the waiver meets the assurances and other requirements contained in this application. Through an ongoing process of discovery, remediation and improvement, the state assures the health and welfare of participants by monitoring: (a) level of care determinations; (b) individual plans and services delivery; (c) provider qualifications; (d) participant health and welfare; (e) financial oversight and (f) administrative oversight of the waiver. The state further assures that all problems identified through its discovery processes are addressed in an appropriate and timely manner, consistent with the severity and nature of the problem. During the period that the waiver is in effect, the state will implement the Quality Improvement Strategy specified in **Appendix H**.
- **I. Public Input.** Describe how the state secures public input into the development of the waiver:

The State posted this amendment on August 14,2020 for thirty days to solicit public comment, which ended September 14, 2020 at 5pm PST. The DHCFP posted a web link under the DHCFP Home Page with information about the FE Waiver amendment for the rate reduction, giving providers and the public the opportunity to offer their input for the proposed changes.

Due to Nevada's Governor declaring a public state of emergency, the DHCFP held a public hearing via webex on August 13, 2020 at 9am PST. The public agenda was posted at

Although, the FE Waiver rate reduction was not included in the public hearing, the FE Waiver proposed rate reduction was included in the public agenda.

The State sent tribal letter on July 23, 2020 to notify the tribal government of all Medicaid Provider (all provider types) rate reduction.

There were no comments received by mail or fax. However, the DHCFP received few comments/suggestions/concerns regarding the rate reduction and how it will impact their businesses via email:

With the rate reduction, it is difficult for provider agencies to maintain caregivers, which will impact the services provided to FE Waiver recipients. Another comment, indicated that with the rate reduction, many small businesses will not be able to keep employees for very much longer and afraid that they will close their businesses. One comment, expressed concern on how they will be able to hire/maintain qualified providers to serve the FE Waiver population. Some suggested to instead of reducing the rate, to cut the service hours per recipient. One commented that with the decrease in Medicaid service rate, comes the increase in minimum wage and how is the state expect for any business to survive.

Some concerns and comments pertained to rate reduction but not for FE Waiver - those were forwarded to the appropriate unit within the DHCFP to address.

State Response: The Division of Health Care Financing and Policy (DHCFP) understands your concern. But due to COVID-19 pandemic and economic downturn, NV faced a budget shortfall. NV held a special legislative session in July 2020 which approved the 6% rate reduction of Medicaid providers which unfortunately also affected provider types 48, 58, 57 and 59 providing waiver services. The division is unable to overturn that decision.

However, in 2017, the NV legislature passed Assembly Bill 108, which mandates that the DHCFP reviews Medicaid services rates at least every 4 years. This year's Medicaid rate reviews include waiver services rates. The division cannot promise or guarantee rate increase next year as those are reviewed and approves by the NV Legislature.

J. Notice to Tribal Governments. The state assures that it has notified in writing all federally-recognized Tribal

Governments that maintain a primary office and/or majority population within the State of the State's intent to submit a Medicaid waiver request or renewal request to CMS at least 60 days before the anticipated submission date is provided by Presidential Executive Order 13175 of November 6, 2000. Evidence of the applicable notice is available through the Medicaid Agency.

K. Limited English Proficient Persons. The state assures that it provides meaningful access to waiver services by Limited English Proficient persons in accordance with: (a) Presidential Executive Order 13166 of August 11, 2000 (65 FR 50121) and (b) Department of Health and Human Services "Guidance to Federal Financial Assistance Recipients Regarding Title VI Prohibition Against National Origin Discrimination Affecting Limited English Proficient Persons" (68 FR 47311 - August 8, 2003). **Appendix B** describes how the state assures meaningful access to waiver services by Limited English Proficient persons.

a. Describe the differences between the services covered in the approved waiver and those covered in the new or renewed/amended waiver. Specifically, describe the rate reduction and all of the affected services?

All direct and non-direct waiver services affected by the rate reduction are:

- Case Management
- Homemaker
- Respite
- Adult Companion
- Adult Day Care
- Augmented Personal Care (APC)
- · Chore Services
- Personal Emergency Response Systems (PERS)

The only change between the covered services (direct and non-direct) in the approved waiver and the amendment is the rate of each service provided. With the rate reduction, the impact on the provider agencies could be shortage of available caregivers to provide waiver services. However, in addition to the pool of provider agencies available and willing to provide services to waiver recipients, the state has a self-directed model, Intermediary Services Organization (ISO), where a live-in relative (not Legally Responsible Individual (LRI)), or a friend, or a neighbor can apply as paid caregiver through an ISO agency. This model is optional to all waiver recipients capable of directing their own care. As an ISO caregiver, the caregiver has the option to either just provide services solely to their family (waiver recipient) and/or extend the services to other recipients.

Based on the Nursing Facility (NF) level of Care (LOC), the Aging and Disability Services Division (ADSD) Case Managers (CM) will continue to assess and determines what waiver services a recipient needs to remain in the community.

b. How the health and welfare of persons who receive the affected services will be assured?

Waiver services is an extension of State Plan Option Personal Care Services (PCS). All waiver recipients are also receiving PCS in addition to the FE waiver services, and there are no changes in services or the hours that recipients are currently receiving. The state also has other Medicaid State Plan option services that can supplement waiver services.

c. How the limitations will be implemented?

Once CMS approves the amendment, the fee schedule will be updated to reflect the adjusted rate, which will be entered into the Medicaid Management Information System (MMIS) Interchange. At this time, the rate change has not been implemented and no action has been taken. As indicated above the impact is on the provider agencies. ADSD CMs, through monthly contacts, inform recipients that there are no changes or reduction in their current services. On the recipient rights, it is stated that the recipient must notify their CM if there's no available caregiver who can provide the services. CM will assist in contacting the provider agency for list of caregivers. Moreover, during recipient's initial assessment and annually thereafter, recipients are informed to provide a back-up plan in the event that no caregiver is available to provide services, and this is also provided on the provider's agreement form signed by recipient. Further, provider agencies must have an agreement with another provider agency to serve as a back-up for each other, if one is unable to find available caregivers.

d. How and when the participants will be notified of the changes and will be informed of the opportunity to request a Fair Hearing?

There is no reduction in services and the rate reduction affects the Medicaid providers. The anticipated impact on the recipients, is the shortage of caregivers and as mentioned throughout this section, the state has other options available for the recipients. Recipient has the right to a fair hearing when they are denied of services, or when services are reduced, suspended or terminated, which none of the services specifications from the approved waiver have been changed on this amendment.

- e. How the provider rate reduction does not adversely impact participant benefit services including:
- i. Outline the process the state will implement to ensure participant services will not be reduced following implementation of the 6% provider rate reduction?

To ensure the health and welfare of recipients that might be affected due to the reduction of rate, the ADSD CMs conducts monthly contact with the recipients to ensure satisfaction with services, the health and welfare, and assist with additional services.

ii. Provide a back-up process the state will follow to ensure a seamless delivery of waiver services if providers dis-enroll resulting from the rate reduction?

With this rate reduction and COVID-19 pandemic, we've had providers closing their doors for all individuals and not just for waiver recipients. However, the state has approximately 100+ providers, which also include ISO agencies that have stepped up to the plate and accepted the recipients affected by the closure. ADSD case managers assisted in the transition of those

recipients.

iii. Provide the name of entities that will provide Medicaid services to supplant waiver services resulting from rate reduction? The state has approximately over 100 provider agencies that are still willing to provide the waiver and PCS services in light of the rate reduction. For continuity of services, the state also has safeguards in place to assure CMS that recipients will receive services without disruption. As Medicaid providers, they must adhere to their contract with Medicaid (Medicaid Service Manual Chapter 100) to provide services. Should the Medicaid provider decide to dis-enroll as a Medicaid provider, they must notify DHCFP and ADSD within 30 days prior to closing their agency. During the 30-day window, provider will assist ADSD CM in finding another placement for the affected recipients. Typically, ADSD CM will provide a list of providers to the affected recipients to choose from, and once recipient has chosen a provider, the closing provider will assist the recipient in transitioning to another provider. Furthermore, the state licensure agency, Bureau of Health Care Quality and Compliance (HCQC), is assisting ADSD and DHCFP for additional monitoring of state licensed providers to ensure the health and well-being of recipients and assisting with additional placement if needed. The state has few large provider agencies which also serve as PCS, Waiver and ISO agencies. As mentioned throughout this section, each provider already have an agreement (signed by both parties) in place with another provider as back-up for each other.

iv. Identify the process the ADSD, the Operating Agency, will implement to assist participants transfer to alternate agencies for personal care services?

ADSD case managers (CM) assist all recipients who are receiving waiver and non-waiver services in transitioning to another provider as needed and/or requested. When a recipient regardless of the reason, wish to change provider, the CM will provide the recipient a list of providers to choose from; once the recipient reviewed and chose a provider, the CM will assist the recipient from making a phone call to the chosen provider, request the necessary transfer of prior authorization (if applicable) to the DHCFP fiscal agent, etc.

Continued from Appendix I:2a Rates, Billing and Claims

Public Case Management - The Aging and Disability Services Division (ADSD) set the initial rates in 2002 using actual costs for case management. In 2005, the rate was reviewed, and a 20% increase was proposed by ADSD again using actual costs for case management in 2005. The rate increase was approved by DHCFP. Case Managers must provide recipients with appropriate amount of case management services necessary to ensure the recipient is safe and receives sufficient services. Case managers must, at a minimum, have monthly contact with recipients and/or the recipients authorized representative of at least 15 minutes per recipient, per month. Only costs directly attributable to case management services and a reasonable allocation of indirect costs are included in the rate. Indirect costs are developed in conformance with the Division's cost allocation plan and include agency administrative costs and travel, as ADSD is currently the single provider of case management services, including all rural Nevada. Rates that are active in the system as of December 1, 2020 will be reduced by 6% until June 30, 2021. Rates will be restored to the pre-reduction amount by July 1, 2021. This rate will be reviewed in the future on a legislated schedule, at least every 4 years.

Private Case Management - This is a wage-based rate developed in 2006 as part of the Behavioral Health Redesign approved by the 2005 Legislature. Through analysis of the skill level of individuals rendering service and the delivery model, a rate model was developed from an hourly base wage and increased to reflect service definitions, provider requirements, operational service delivery and administrative considerations.

- 1. Wage information is taken using State of Nevada Personnel 2006 Compensation Schedule for a Licensed Clinical Social Worker (SWSII). 2. Employee related expenses (ERE) percentage of 27% is based on input from Medicaid Staff and approved State Plan direct care service methodologies. It includes paid vacation, paid sick leave, holiday pay, health insurance, life insurance, disability, workers compensation, and legally required payroll taxes.
- 3. Productivity adjustment factor accounts for non-billable time spent by staff and includes "no shows", phone calls, etc. leaving "billable hours" equal to 6.4 hours per day or 80% based on an 8-hour day. Productivity assumptions are based on input from waiver policy staff and experience of ADSD case management staff.
- 4. Supervision Allowance of 5% is added to the base wage for supervision of case managers and divided by the number of individuals supervised (5) to arrive at an average supervisory cost per hour.
- 5. Administrative overhead, 10%, is the percentage of service costs allowed by Nevada Medicaid's State Plan for non-direct care activities including insurance, administrative staff, operations and management activities and office supplies. This does not exceed the percentage allowable by state law.

Augmented Personal Care – According to DHCFP's historical data rate were established based on Oregon's Medicaid rates for 2006. When the new Augmented Personal Care level 4 was approved along with a 15% increase, the DHCFP used Oregon's rate for level 4, to remain consistent, and then added the 15% rate increase approved by the Legislature. The rates were then rounded up to the nearest dollar.

Rates that are active in the system as of December 1, 2020 will be reduced by 6% until June 30, 2021. Rates will be restored to the pre-reduction amount by July 1, 2021.

Adult Day Care – The ADSD set the initial rates in 2004 using actual costs for Adult Day Care. In 2017, the State Legislature approved a 5% increase in the rate.

The following steps are used to determine the rates:

- 1. The State will use the hourly base wage.
- 2. The hourly amount is increased by the 27% ERE.
- 3. A productivity factor is applied to the hourly compensation increased by the ERE calculated in Item 2.
- 4. The wage arrived at in Step 2 is increased by the allowance for supervision.
- 5. Administrative overhead (10%) is applied to the adjusted hourly rate. (Item 4).
- 6. Total hourly rate is the sum of the adjusted hourly rate, increased for supervision and increased by the administrative overhead (Item 5).
- 7. Total hourly rate is scaled to the proper unit based on the unit of service.

This rate will be reviewed in the future on a legislated schedule, at least every 4 years.

The fiscal agent is the Quality Improvement Organization (QIO)-like Vendor and operates as the utilization and quality control for all DHCFP Medicaid programs and is contracted by DHCFP. For the purpose of this FE Waiver renewal and for consistency, the QIO-like Vendor will be referred to as the fiscal agent.

The division has established program policies and procedure for all provider types – Medicaid Manual Service (MSM) Chapter 100 Medicaid Program. In addition, each provider type and specialty established additional policy and procedures. The fiscal agent implement those policies and procedures when enrolling provider applicants. Provider applicants submit application electronically through the fiscal agent's website; enrollment checklist is available on the website as well for instruction and required documents. All provider applicants are processed according to each provider type and specialty requirements.

The DHCFP Provider Enrollment Unit monitors and works closely with the fiscal agent. For example, when processing provider application (PT 48) and additional clarification pertaining to policy and approval is required, the provider enrollment unit will consult with the DHCFP LTSS Waiver Unit.

The fiscal agent's other responsibilities: claims processing, MMIS Interchange updates or fixing system errors, assists providers with claims denials, disseminating policy updates/changes to providers via web announcement posted on their website, reviews and approves authorization requests for several procedure/service codes requiring prior authorizations including pharmacy related requests, and prepares a monthly report of all provider enrollments by provider type for DHCFP review. Certain Medicaid State Plan Option programs such as State Plan PCS, the fiscal agent assess/re-assess and approves Medicaid recipients for the PCS program.

NOTE: Waiver services which require prior authorization is done by ADSD.

All provider agreements with DHCFP terminate 5 (five) years from the enrollment date. Providers must revalidate through the fiscal agent who verifies provider qualifications and revalidate providers.

DHCFP is responsible for fiscal agent monitoring. The fiscal agency provides a series of reports to the Medicaid agency on a monthly basis using a system called ODRAS. These reports include provider enrollment, claims data, and prior authorization data.

In addition, individual units receive quarterly programmatic information directly from the fiscal agent.

Due to the complexity of waiver reporting, the fiscal agent provides an annual report on waiver utilization which includes:

- Unduplicated count
- · Medicaid eligibility code
- Primary diagnosis
- Age
- · Total expenditures for program
- · Total expenditures by service
- Total state plan expenditures for waiver recipients
- · Service utilization by recipient
- · Expenditures by recipient

The fiscal agent is required to submit Key Performance Measures (KPI) on an ongoing basis to the DHCFP Information Systems Project Management Office who is responsible for overseeing the contract with the fiscal agent. There are other units within DHCFP who monitor the fiscal agent such as Provider Enrollment for enrollment and Fiscal Integrity for claims.

DHCFP has provider agreements in place with providers.

The fiscal agent enrolls providers initially and every five (5) years thereafter. During enrollment/revalidation, the fiscal agent reviews provider qualifications and does not enroll any provider who does not meet qualifications.

The DHCFP Hearings Unit is responsible for all Medicaid participants' appeals; works closely and communicate with the specific Medicaid program specialist and other responsible state staff who made the adverse decision. The Hearings Unit also monitors and tracks hearings and appeals for waiver services as well as all Hearing Preparation Meetings (HPM), fair hearings and outcomes and the report is available upon request.

The DHCFP Nevada Medicaid Services Manual Chapter 100 is located on the DHCFP website and outlines provider requirements and administrative sanctions. The DHCFP has a Provider Support unit that tracks providers who are on sanction periods.

The DHCFP Quality Assurance (QA) Unit conducts annual programmatic and financial review of this waiver which is structured as a look back review of delegated functions. The DHCFP has the ability to break out the review findings by geographical office or Statewide, to identify trends that may be applicable to a specific regional office or generalized program issues.

The State strives for a sample size producing a probability of a 95% and a confidence level of 5%. The State accomplishes this in the following ways:

A 95/5 sample of chart reviews is completed by combining annual supervisory chart reviews with annual QA reviews, utilizing the same review tool;

A 95/5 sample of participant satisfaction is completed by combining ADSD PES reviews with the annual QA PES reviews, utilizing the same tool;

A 95/10 sample of recipient financials is completed annually by QA staff. The state is unable to complete a 95/5 sample of financials due to lack of resources; however, there are other reviews completed by PERM, Fiscal Integrity, and the DHCFP Surveillance Utilization Unit that cover waiver financials.

100% of providers are reviewed annually for compliance with provider requirements by a combination of the DHCFP and the Aging and Disability Services Division (ADSD) staff. The ADSD QA performs annual on-site reviews of providers. During this review the provider qualifications, employee files, training, recipient files, and one month billing is reviewed and verified. A maximum of 5 employee files are reviewed, a maximum of 5 recipient files and billing for one month for each recipient are reviewed. If a facility has less than 5 recipients or caregivers, then the review is 100%. If they have more than 5 of each, a random sample of 5 is pulled. Then all review results are entered into the ALiS Database, which was built to hold with a maximum of 5 recipients or caregivers at a time. The sample size of 5 recipients/caregivers is determined by HCQC, state licensure agency. Training is provided during reviews to include as appropriate a copy of the Medicaid Services Manual, Serious Occurrence power point and forms, and Activities of Daily Living (ADL) Log power point and forms. An alert memo is created and stored in the electronic Provider Database that is shared between ADSD and DHCFP which includes training materials given to the provider. ADSD maintains a spreadsheet of trainings provided which is reviewed on an ongoing basis and if there are any trends they are discussed at the quarterly Quality Management (QM) meetings. Follow up visits by designated QM staff is completed when indicated. Providers can also requests additional training on topics of their choice.

A management report of the annual review is prepared and distributed as applicable, which includes the review findings listed above. An important goal of the annual review is to address and document broad issues and outcome measures, incorporating methods and criteria for prioritizing findings, and to improve documentation of remediation efforts and successes. The priority for these improvements is balanced by available staff and other necessary resources.

This annual report is used to identify any problems or issues with the waiver, to include training for case managers or providers, systems issues, or policy clarifications that both DHCFP and ADSD will work to resolve over the next year.

b. Methods for Remediation/Fixing Individual Problems

Deficiencies are remediated through corrective strategies discussed in the quarterly quality management meetings to assure coordination of processes across the state and based on findings in the annual review and subsequent plan of improvement. The ADSD quality management specialist is responsible for monitoring progress based on established timelines and for reporting progress to the DHCFP.

The monthly unduplicated list of waiver participants, ongoing caseload and wait list is used to check accuracy of information on waiver and DHCFP fiscal agent to assure accuracy of information on waiver eligibility status whenever claims are denied. If needed, corrections are sent to the DHCFP Long Term Services and Support (LTSS) staff who corrects the data for the monthly report. Continued discrepancies are reported to the ADSD Community Based Care Chief, who reviews the issue with the DHCFP for resolution.

As issues arise, the ADSD and the DHCFP have meetings to discuss and solve problems. The issue is prioritized and incorporated into a priority spreadsheet, and monitored, until resolution occurs.

The ADSD staff participates in the review and revision of the Medicaid Service Manual policy updates to ensure that waiver requirements are met.

The DHCFP has a contractual agreement with the fiscal agent to enroll qualified providers. The contract identifies the responsibilities of the fiscal agent. The fiscal agent is required to enroll only qualified providers and prepare a monthly report by provider type on enrolled providers and providers who did not meet qualifications. The DHCFP staff reviews these reports on an ongoing basis.

Additionally, the ADSD supervisory staff intervenes and counsels case managers to resolve individual client problems or documentation issues. If an issue has the potential to recur, it is reviewed with all supervisors during the monthly supervisors meeting to ensure that they are aware and can take steps to prevent recurrence.

To improve applicants' wait time to get on the waiver program, the new process for eligibility for the Home and Community-Based Services Waiver for the Frail Elderly is determined by the combined efforts of the ADSD and the DWSS. These two State agencies will work collaboratively to determine eligibility. This new process will also be adopted by other Nevada's Home and Community Based Services Waivers.

The ADSD case managers gather data and evaluate applicants or recipients to ensure they are 65 years of age or older, meet and maintain a nursing facility Level of Care, require an ongoing monthly waiver service and who, but for the provisions of services, would require imminent placement in a nursing facility within 30 days if HCBS were not available.

Referrals come from many different means to include family members, providers, hospitals, nursing facilities, non-profit organizations, and recipients themselves. Applicants are all evaluated and if deemed to meet eligibility requirements, and no slots are available, applicants are placed on the waitlist by priority. The waitlist priority is as follows:

- 1. Applicants currently in an acute care or NF and desiring discharge;
- 2. Applicants who require maximum assistance and/or are dependent in all three areas of eating, bathing, and toileting;
- 3. Applicants requiring services due to a crisis or emergency such as a significant change in support system;
- 4. Applicants transitioning from another waiver;
- 5. Applicants with a terminal illness; or
- 6. Applicants who do not meet the criteria for priority levels 1-5.

The operating agency is responsible for management of the wait list and allocation of available slots.

The DHCFP monitors the unduplicated count of recipients being served year to date, including current open and closed cases using monthly reports sent to the DHCFP Central Office by the ADSD. On a monthly basis, the DHCFP LTSS Unit staff reviews a retrospective random sample using 95/5 of the approved intake packets to ensure the packet is complete for entrance onto the waiver. This review includes: a)The Comprehensive Social Health Assessment (CSHA) Form (all pages included); b) nursing facility level of care criteria is met; c) there is a waiver service need; d) financial eligibility established or pending with the DWSS; e) Statement of Understanding (SOU) signed, initialed, and dated by the recipient or designated representative; f) Acknowledgement Form signed, initialed, and dated by the recipient or designated representative; g)Individualized goals are identified on the POC and h) the applicant has been informed of their right to participate in the development of the plan of care (POC) using the person centered approach with the support systems, friends, family of their choice involved.

Findings of these packet reviews are prepared quarterly and sent to the ADSD quality assurance specialist for inclusion in the quarterly quality management meeting. The DHCFP staff attends the quality management meeting and provide feedback to the ADSD regarding packet review findings. Data gathered is incorporated into the evidentiary report and corrective action plans as appropriate.

The DWSS validates that the applicant/recipient is eligible for Medicaid waiver services using institutional income and resource guidelines.

The Level of Care Tool consists of five categories which include: ability to self administer medication, treatments and special needs, activities of daily living, need for supervision, and instrumental activities of daily living.

The total numeric score from the assessment tool determines whether an applicant meets nursing facility LOC. There are 13 total functional deficits identified on the Level of Care Assessment Tool. An eligible recipient or pending applicant must meet at least 3 deficits out of the 13 possible.

The five categories are broken down as follows:

Ability to self-administer medication: the inability to safely administer one's own medication counts as one functional deficit - (1);

Treatments and special needs: may include suctioning, ventilator dependent, feeding tube, wound care, glucose monitoring, IV lines, oxygen dependent, and pediatric specialty care among others. Treatments or conditions that an individual performs as self-care aren't included as a functional deficit. A recipient/applicant is only required to have one treatment or special need for this category to be counted - (1);

Activities of daily living: a total of eight functional deficits are possible in the areas of bathing, dressing, grooming, eating, mobility, transferring, ambulation, and continence - (8)

In this category, there are four (4) identifiable levels of assistance. 1) Independent (I) which means the recipient can independently perform this activity or requires no assistance to perform the activity with use of an adaptive device. 2) Supervision (S) which means to the recipient's safety, a caregiver must oversee this activity. 3) Assistance (A) which means the recipient requires help. 4) Dependent (D) which means the recipient is totally dependent on the caregivers to complete this activity for him or her. If any of the areas is determined S, A or D, it counts as a deficit. An area determined as an "I" does not count as a deficit;

The LOC assessment tool is used to screen, assess and reassess that a nursing facility level of care exists to establish eligibility criteria for the waiver. The LOC evaluation and re-evaluation are completed and reimbursed as an administrative function by the operating agency qualified staff with the initial screening visit, annually, and if there is a significant change in condition or circumstances that may affect eligibility. These duties are separate and distinct from case management services covered in the waiver. When a referral is received and assigned, the Intake Specialist makes phone/verbal contact with the applicant or his or her representative within 15 working days of receipt of the referral. Subsequently, there is a face to face visit with the recipient to process the referral, complete the necessary forms, and gather the required documentation necessary to establish program eligibility. The face to face assessment to determine level of care and waiver service need should occur within 45 calendar days of the referral date to assure timely access to services. A screening assessment for level of care is completed to determine if the individual has functional deficits and requires the level of services offered in a nursing facility or a more integrated service that may be community based. The screening tool and the process to assess the level of care is the same for assessments and reassessments. Clients must be assessed at minimum annually while receiving waiver services to reaffirm eligibility, including level of care. If there is a significant change in the client's condition that would affect program eligibility, reassessment is made at that time. The same screening tool is used that nursing facilities utilize.

Evaluation and annual reevaluation of eligibility, assessments, level of care, and POC development are performed and reimbursed as an administrative function by qualified staff of the operating agency. DWSS NOMADS system identifies individuals requiring financial eligibility redetermination which occurs annually. ADSD maintains a case management database, which provides notification when a reassessment is due. ADSD staff also utilizes a tickler system and/or calendar to ensure reassessments are completed as required. Waiver eligibility must be reassessed annually. The ADSD case managers schedule the reassessment visits up to a month prior to the annual anniversary, or as deemed necessary by the ADSD supervisory staff. In order to eliminate the need to conduct multiple home visits with a recipient to complete applications for various programs, reassessments dates may be changed to line up with other programs due dates. The ADSD supervisory staff review a sample size of assessment and reassessments to assure levels of care are accurate.

After a referral for services is received, a qualified case manager (intake specialist) contacts the recipient within fifteen business days to arrange a face-to face meeting within 45 days to complete a LOC screening to determine program eligibility. The same instrument is used in determining the Level of Care for the waiver and for institutional care under the State plan.

If the recipient meets LOC and has a waiver service need, they are placed on a wait list while financial eligibility is determined and for a waiver slot to become available. Once a waiver slot becomes available, a qualified ADSD case manager conducts a face-to-face meeting to complete the initial assessment. This assessment is conducted as an administrative function of the waiver program and evaluates service needs based on functional deficits, support systems, and imminent risk of institutionalization.

ADSD supervisory staff reviews initial assessments to assure accurate LOC determination based on the recipients' functional deficits and appropriateness for program eligibility using the Case File Review Form.

At the quarterly quality management meetings between ADSD and DHCFP, DHCFP will report on the findings of intake packets reviewed on a monthly basis.

ADSD supervisory staff reviews LOC reevaluations to help ensure accurate LOC determinations. Case Managers track redetermination dates as an activity/referral in Social Assistance Management Software(SAMS), which notifies case managers when reassessments are due. After the LOC reassessment is completed, the supervisor reviews the LOC reassessments for timeliness and accuracy. At the time of review, any errors or concerns the supervisor identifies are addressed with the individual case manager for correction or clarification. The LOC reevaluation has been incorporated into the social health assessment. These reviews are submitted to ADSD QM staff monthly, entered into a database, and tracked for timely reassessments, issues, or concerns. The data is reported at the quarterly quality management meetings for recommendations, remedial action, and improvement strategies.

Other monitoring by DHCFP is accomplished using an annual review approach. The DHCFP annual review is designed as a look-back review to confirm the operating agency data. If issues are discovered during the annual review, the review is expanded to determine the extent of the problem, which will be addressed in the Plan of Improvement response to the annual review.

ADSD managers and supervisors have monthly meetings to bring issues to the group so that trends can be identified and addressed statewide.

Identified training needs are incorporated into planning educational offerings for ADSD staff.

b. Methods for Remediation/Fixing Individual Problems

ADSD supervisory staff addresses concerns or issues as they are identified with the case manager. The supervisor reviews the assessment to assure the individual meets the required LOC score, has a waiver service need, and meets all eligibility criteria. When the supervisor identifies errors, omissions, or concerns they are addressed with the case manager for correction at that time.

Deficiencies are remediated through corrective strategies discussed in the quarterly quality management meetings to assure coordination of processes across the state. The ADSD quality management specialist is responsible for monitoring progress based on established timelines and for reporting progress to DHCFP.

Monthly manager/supervisor meetings are held to discuss issues so statewide trends among the ADSD District Offices can be identified. Issues addressed at these meetings are discussed and remediation is completed through feedback and discussion of additional training needs at team meetings with ADSD staff. Training is provided to staff during monthly meetings and as needed. Procedures and processes are reviewed to ensure consistency and effectiveness.

Deficiencies are remediated through corrective strategies discussed in the quarterly quality management meetings to assure coordination of statewide processes. If an issue is identified to be widespread, a workgroup will be formed to develop and implement a corrective action plan and identify additional training needs. The ADSD quality management specialist is responsible for monitoring progress based on established timelines and follow-up to DHCFP.

ADSD participates with DHCFP in updating policy changes to the Medicaid Services Manual. In working together, policy changes are identified based on Quality Management meetings, deficiencies noted in annual reviews, and trending reports.

For applicants/recipients who are non-English speakers, DHCFP utilizes Limited English Proficiency services through Language Link, which also provides Sign Language Interpretation Services and is contracted by DHCFP. Additionally, DHCFP also utilizes staff who are bilingual.

A record is established for each recipient. Personal care and supportive services (homemaker, chore, attendant services, meal preparation) that are furnished to waiver participants who reside in a setting that meets the HCB setting requirements and includes 24-hour on-site response capability to meet scheduled or unpredictable resident needs and to provide supervision, safety and security. Services also include social and recreational programming, and medication assistance (to the extent permitted under state law). Services that are provided by third parties must be coordinated with the assisted living provider.

Augmented personal care is over and above the mandatory service provision required by regulation, which includes the coordination of transportation to and from the residential facility for groups to the hospital, a nursing facility, routine medical appointments and social outings organized by the facility. This service includes 24-hour in home supervision to meet scheduled or unpredictable needs.

Other individuals or agencies may also furnish care directly, or under arrangement with the group home or assisted living, but the care provided by these other entities is supplemental and does not relieve the group home or assisted living facility from their primary care duties.

Nursing and skilled therapy services (except periodic nursing evaluations if specified above) are incidental, rather than integral to the provision of group care and assisted living services. Payment will not be made for 24-hour skilled care or supervision. Federal Financial Participation (FFP) is not available for room and board, items of comfort or convenience, or the costs of facility maintenance, upkeep and improvement. The costs of room and board are excluded from payments for assisted living services.

There are four levels of augmented personal care covered in this waiver. The service level provided is based on the recipients functional, cognitive and behavioral needs to ensure his or her health, safety and welfare in the community. The case manager determines the service level. If the case manager is an employee of ADSD, they also complete the prior authorization for services. If the case manager is from a provider agency, that case manager must communicate the service level to ADSD for completion of the prior authorization for services.

Level One Daily (minimum assistance)

Requires supervision and cueing to complete basic self care and ADLs with minimum hands on care; in home supervision when direct care tasks are not being completed. Minimum assistance with laundry; housekeeping; meal preparation and eating; bed mobility and transfers; bathing, dressing and grooming; mobility and ambulation.

Level Two Daily (moderate assistance)

Requires physical assistance to complete ADLs with moderate hands on care; in home supervision with regularly scheduled checks as needed. Moderate assistance with increased laundry needs; housekeeping; special meal prep and eating; bed mobility and transfers; bathing, dressing and grooming; mobility and ambulation.

Level Three Daily (maximum assistance)

Requires physical assistance to complete ADLs with maximum hands on care; direct 24 hour supervision and/or safety system (alarm) to ensure safety when supervision is not direct. Maximum assistance with increased laundry needs; housekeeping; special meal prep and eating; bed mobility and transfers; bathing, dressing and grooming; mobility and ambulation.

Level Four Daily (Critical Behaviors)

In addition to meeting a level of one, two or three for ADL/IADL care, level 4 requires substantial and/or extensive assistance with critical behaviors: Behavioral Problems, Resists Care, Socially Inappropriate, Wandering, Physically Abusive to self and/or others, Verbally Abusive, and behaviors that represent a safety risk. Requiring the full attention of staff member when behaviors are present and/or presents a need for additional staffing to redirect and address behaviors. Additional documentation and agency approval required.

*All service levels are reassessed annually, or as significant changes occur, and may increase or decrease to reflect the recipients current level of need. Cognitive and/or critical behaviors are considered in the Level of Care Determination and may cause a recipient to be assessed at a different APC Level than originally determined.

*Documentation on the daily log is required to justify amount and types of care for service level determination and

verification of proper billing.

Case Manager assesses and authorized APC service level based on the level of care needs using CSHA which the NF LOC tool is incorporated.

AGING AND DISABILTTY SERVICES DIVISION (ADSD) EMPLOYEES:

The ADSD, in compliance with the Department of Health and Human Services (DHHS), requires a criminal background check of any person appointed to a position in the classified or unclassified service whose duties include regular or potential contact with clients of the Division or access to client records. State agencies use NRS 239B.010 "request by agency of State or political subdivision for information on certain persons from Federal Bureau of Investigation" as the citation to request background checks. A criminal background check is required as a condition of employment for any person accepting employment with the agency, to include appointment as a new hire, reinstatement, reemployment, reappointment or transfer.

Employees are fingerprinted within five working days of their date of hire or appointment.

It is the responsibility of an employee's supervisor to ensure fingerprint cards are completed and submitted to the designated Division Personnel Staff who has the responsibility of submitting the fingerprint cards to Central Repository for Nevada Records of Criminal History, an agency of the Nevada Department of Public Safety, Records and Technology Division. The results of the state and national FBI criminal history search are transmitted back to Personnel, who notify the ADSD Administrator or Deputy Administrator of any positive results. The ADSD Administrator or Deputy Administrator takes any action necessary as a result of the background check.

WAIVER PROVIDERS:

The DHCFP policy requires all waiver providers to have State and Federal criminal history background checks completed. Based on the results of the background check, the DHCFP fiscal agent will not enroll any provider agency whose operator has been convicted of a felony under Federal or State law for any offense which DHCFP determines is inconsistent with the best interest of recipients.

A fingerprint based criminal background check is required for all employees who provide direct care to recipients, as well as owners and administrators. Internet based background checks are not acceptable.

The DHCFP policy requires all providers have a fingerprint based criminal history completed prior to service initiation, and every five years thereafter. The DHCFP fiscal agent will not enroll any provider agency whose owner or operator has been convicted of a felony under State or Federal law for any offense which the DHCFP determines is inconsistent with the best interest of recipients. Additional information may be found in MSM Chapter 100, Section 102.2, which outlines a list of crimes which are inconsistent with the best interests of the recipients.

Criminal background checks must be conducted through the Nevada Department of Public Safety (DPS). Agencies do not have to have a DPS account. Individuals may request their own personal criminal history directly from DPS and the FBI and must have the results sent directly to the employer. Additionally, all waiver services must be prior authorized prior to providing services; and, ISO entities are subject to DHCFP and ADSD Quality Assurance (QA) units' review, which is reported to CMS. Relative caregivers also have individual case file kept in the ISO agency and are reviewed annually. The case file must contain training certificate, plan of care, daily logs signed by recipient and caregiver (NOTE: if recipient is unable to sign daily logs and documented in the POC, the log must be signed by another relative, who is not the caregiver).

When during the QA review, it was determined that caregiver was non-compliant, the case is also referred to DHCFP Surveillance and Utilization Review (SUR), for further investigation and possible recoupment.

The fiscal agent processes claims through the Inter Change system, makes payments to providers, and tracks payment via Remittance Advices (RAs).

All providers under this waiver are licensed or certified with the State except PERS providers.

The DHCFP conducts annual program and fiscal reviews of services provided under this waiver. The annual review is structured as a look-back and includes review of provider qualifications to ensure ongoing compliance with waiver requirements. Additionally, the Bureau of Health Care Quality and Compliance (HCQC) conducts audit of all providers on a yearly basis for renewal of state licensure.

ADSD also performs annual provider reviews on all waiver providers. If problems are discovered during the review, staff takes appropriate action and provides education and training to the provider. An Alert Memo is forwarded to the DHCFP and HCQC as indicated based on the identified issue or deficiency noted. A Corrective Action Plan (CAP) may be required for remediation or the provider may be suspended or terminated. The action taken depends on the nature of the problem and the action of the provider to correct and prevent recurrence of the problem.

HCQC also conducts investigation, and findings are reported to DHCFP Provider Enrollment Unit. Once DHCFP receives a referral for investigation, DHCFP Provider Enrollment Unit conducts a thorough provider investigation for further action including termination.

During monthly contacts, a case manager may identify a situation where providers are not meeting requirements. The case manager will then address the concern with the provider and/or ADSD staff. If a resolution cannot be reached, the recipient will be given the option of choosing a different provider of services. If resolution is achieved, the case manager will follow up at the time of next contact. Additionally, the issue can be reported up the supervisory chain of command for evaluation and problem solving. Deficiencies are remediated through corrective strategies discussed in the quarterly QM committee meetings to assure coordination of processes across the state. The ADSD quality assurance specialist is responsible for monitoring progress based on established timelines and for reporting progress to he DHCFP. The quality management specialist may change processes to provide more efficiency.

Deficiencies are remediated through corrective strategies discussed in the quarterly QM committee meetings to assure coordination of processes across the state. The ADSD quality assurance specialist is responsible for monitoring progress based on established timelines and for reporting progress to DHCFP.

The results of DHCFP waiver reviews are used as the basis for discussion between DHCFP and ADSD to create a joint Plan of Improvement (POI) and monitored for progress at subsequent reviews by the DHCFP. The ADSD quality management specialist monitors progress on the POI quarterly.

The ADSD reviews a sampling of employee files during their annual visit as well. If a provider does not meet criteria, then a letter is sent documenting the deficiencies and a plan of improvement is required. A follow up review is scheduled to validate that the plan is being followed. The DHCFP monitors progress on plans of improvement.

At this time, NV has not reached the CMS final approval. At the State's initial approval, residential and non-residential settings are both partially compliant. With the crisis at hand, the State is currently focusing on establishing procedures and processes related to COVID-19 pandemic, which put DHCFP LTSS unit to a halt in working with providers and ADSD to become full compliant.

As time permits, NV will focus on validating residential and non-residential settings to ensure HCBS requirements are met. NV will resume other action steps to come into compliant such as updating the policies to enforce the HCBS requirements. Additionally, DHCFP has established various working groups to design a plan to bring all settings into compliance and have ongoing monitoring as per 42CFR 441.301 (c)(4)-(5). All waiver providers and stakeholders are aware of the HCBS new rule requirements and how their input and collaboration during this process will be needed for implementation. The DHCFP will be providing CMS ongoing updates on the progress of achieving full compliance and to reach the final approval.

c. Supporting the Participant in Service Plan Development. Qualified case managers develop the Plan of Care (POC) using the person-centered approach and as an administrative activity of the waiver program. ADSD has identified national experts to provide specialized training in person centered thinking. All agency staff and designated DHCFP staff will receive this training which will also include concurrent train the trainer certifications for ongoing continuity.

Person Centered thinking includes involvement and choice by the applicant/recipient and/or designated representative to establish the frequency, duration, and method of service delivery; is driven by the individual, designated representative, legal guardian or other supports chosen by the individual and includes necessary information and support to ensure that the individual directs the process to the maximum extent possible. The Case Managers guides the process by explaining the recipient's rights and responsibilities, processes, requirements and providing information about the range of services and supports offered through the waiver, which allows the recipient to make informed choices, at the same time, addressing the health, welfare and safety of the applicant/recipient.

Person Centered planning includes convenience to the recipient, cultural considerations, use of plain language, strategies for solving any disagreements, identification of what is important to and for the individual, personal preferences, choice of caregivers, strategies to facilitate health and welfare and remediate identified risks, identified goals, outcomes, preferences related to relationships, community integration and opportunities to participate in integrated settings, opportunities to seek employment or volunteer activities, control over personal resources.

The Statement of Understanding/Choice form is used to inform applicants of their rights and the right to choose between home and community-based waiver services or placement in a nursing facility and is signed by the recipient or designated representative. Additionally, the recipient's rights form is reviewed with and provided to recipient and or/designated representative which include choice of service provider and may request a change in services or service provider at any time.

A POC must be established for all applicants, who have been awarded a waiver slot and all recipients. The POC includes, at a minimum, the individual's needs, goals to meet those needs, identified risks, services to be provided, case management and non-waiver services. Case managers will assist the recipient in gaining access to necessary state plan and waiver services as well as needed medical, social, educational, and other services, regardless of funding sources.

With the person centered approach, as part of case management service – case managers' contacts with recipients must be made to sufficiently verify that services are being provided appropriately or as outlined in the POC, and identify changes in condition or service needs. Contacts may be by telephone, fax, email, or an in-person visit as outlined in the POC development process.

Plan of Care (POC) development is completed and reimbursed as an administrative function of the waiver program. ADSD case managers develop the POC, in conjunction with the Level of Care and Comprehensive Social Health Assessment (CSHA). The applicant/recipient and family members, support system and/or designated representative of the individual choosing are encouraged to participate in the planning process. The POC is developed following the person-centered approach.

- (a) Initial development of the POC and annual updates are completed as an administrative activity. The POC is completed no more than 60 calendar days from waiver enrollment. The finalized service plan must be signed and dated by both the recipient and provider(s). Ongoing POCs are updated and revised when there is a significant change expected to last more than 30 days that occurs outside of the annual review.
- (b) The assessment process includes addressing the applicant/recipient's needs and individualized goals identified in the CSHA. This assessment process includes addressing activities of daily living (ADLs), instrumental activities of daily living (IADLs), service needs and support systems. In addition, this process includes gathering information regarding the medical history and social needs. The POC process considers risk factors, equipment needs, behavioral status, current support system, and unmet service needs. A list of available waiver services is provided to the recipient and/or his or her representatives. Development of the POC considers the recipient's location, availability of transportation, and necessary or desired activities to ensure preferences can be met. Personal goals are identified by the recipient and documented on the POC initially and each time the POC is updated.
- (c) At the applicant's initial contact with the ADSD, the applicant is informed of services available through the waiver. An informational brochure is provided to the applicants describing these services. The information is provided to the applicant at the time of the initial assessment. Once on the waiver, the recipient receives a copy of the initial POC, when the POC is revised based on a significant change expected to last more than 30 days that occurs outside the annual review and annually.
- (d) The recipient is an active participant in developing the POC that identifies desired outcomes, needs and preferences. The POC development process ensures that participant goals, needs, and preferences are addressed through the inclusion of the recipient, involved family members, personal representatives, and providers. Choice of service and providers are integrated in the planning process.
- (e) The POC identifies the services required, including type, amount, duration, scope and frequency of services. Specific tasks, risk factors or direction are noted. The service providers are contacted by phone to establish availability and provided with a copy of the recipient's POC prior to initiation of services via fax or e-mail. The assigned case manager reviews the document with the recipient and coordinates the initiation of services with the chosen provider.
- (f) Contact with the recipients are required to be initiated by the case manager to discuss the authorized services and evaluate the recipient's level of satisfaction. Contacts must be made to sufficiently verify that services are being provided appropriately or as outlined in the POC and identify changes in condition or service needs. Contact may be by telephone, fax, or email, and an in-person visit will be conducted annually and as outlined in the POC. During contact or home visits, case managers are responsible to capture feedback from the recipient to help ensure services are delivered as authorized in the POC. Using the person centered approach, case managers, applicants/recipients, family members, support system and designated representatives will determine the method and frequency of contacts. The State will assure that all recipients have appropriate case management on a case by case basis.
- (g) The POC is reviewed and updated at a minimum annually; ongoing POCs are updated and revised when there is a significant change expected to last more than 30 days that occurs outside of the annual review. The case manager is responsible for ensuring the POC is being followed and facilitating revisions of the POC. ADSD supervisory staff reviews a sample of POCs on initial and ongoing cases. DHCFP reviews a sample of POCs during the annual review process. ADSD reviews the provider's compliance with POCs during annual site visits.

ADSD case managers are responsible for implementation of the POC for each individual that includes at a minimum, the amount, duration, scope, frequency, and type of provider of services. This is accomplished through the initial assessment, contacts and face to face visits. Information obtained during these contacts is used to update and revise the POC, which occurs at minimum, annually. During the contacts, information such as: changes since last contact, medical appointments, new medications or treatments, hospitalizations, falls, waiver services meeting needs, any new or unmet needs, satisfaction with services, any equipment or supplies needed, or other information is gathered based on interview. Service authorizations are reviewed and updated to facilitate payment. If the recipient requires increased or additional services, the case manager will discuss with the applicant/recipient and/or designated representative. If a new service need is identified, the POC will be updated and the recipient and/or designated representative is given a choice of providers.

Case managers encourage the applicant/recipient, family, support system and/or designated representative to attend face-to-face visits with the recipient. Individuals of the recipient's choice can assist recipients who have cognitive and/or communication difficulties.

In order to assure the health, safety and welfare of recipients and assess on a continual basis recipient's satisfaction with services, the DHCFP and the ADSD administer the Quality Assurance Questionnaire-Participant Experience Survey (PES) which is completed during a visit to the recipient's home or telephone. In addition, the ADSD supervisory staff review selected cases routinely, through the case file review process.

Private case management agencies are required to conduct a sample of cases each quarter for every case manager employed by that agency and providing case management services to waiver recipients. They must report to ADSD the findings of their reviews, the actions taken, and the effectiveness of those actions. Provider case management agencies are required to participate in DHCFP's annual audit. Private agencies will be required to report to the operating agency on 10% of open cases quarterly, for quality management and oversight. Currently there are no private providers providing case management services to waiver recipients.

ADSD utilizes case management database called SAMS database to enter all pending and approved cases of applicant/recipients, POC and contacts of waiver program. DHCFP has access to the SAMS database and utilizes the database to pull a 95/5 random sampling of intake packets (initial assessment, which includes CSHA and LOC, statement of understanding, etc., as well as CMs' case files on a monthly basis. These data are compiled by DHCFP LTSS and QA units using excel spreadsheet. Any errors or deficiencies found are discussed in the monthly and quarterly QI meetings.

On a monthly basis, the DHCFP reviews a representative sample, using the 95/5 Confidence Interval of initial packets and reports findings to ADSD at the quarterly Quality Management meetings. Improvement activies are discussed at these quarterly meetings. The following are included in the findings to ADSD. a) Level of care criteria is met, b) at risk for institutionalization, c) monthly waiver service need d) the Statement of Understanding/Choice is signed by the recipient.

ADSD supervisors review a sample size of ongoing case files producing a probability of 95% confidence level with a \pm 5 confidence interval.

DHCFP conducts annual program and fiscal reviews of services provided under this waiver. A sample size producing a probability of a 95/5 percent confidence level is utilized. The annual review is structured as a lookback review of all delegated functions and confirmation of quarterly data on performance measures provided by ADSD. DHCFP has the ability to break out the findings by the specific policy area. During the review, DHCFP staff evaluates compliance with policies related to the operation of the waiver and assure such policies are administered correctly. Policies are available on DHCFP's website, https://dhcfp.nv.gov, and it is the responsibility of ADSD staff to refer to policy when operating the waiver.

The State has a serious occurrence reporting system in place for provider to report occurrences that happen during the provision of service delivery.

b. Methods for Remediation/Fixing Individual Problems

ADSD supervisory staff reviews the POC to assure that service needs, health and safety risk factors, and personal goals are identified and incorporated into the plan. If these areas are omitted or incorrect, supervisors address this individually with case managers and corrections are made immediately.

The POC is included in the packet of information submitted to DHCFP for review. POC reviews are documented on the Case File Review Form at the time of initial assessment or reassessment. Case file reviews are submitted to quality management as they are completed for entry into a database which will identify areas needing improvement. The results are reported at the quarterly quality management meetings for recommendations, remedial action, and improvement strategies.

The case manager ensures that the services on the POC are assigned the appropriate prior authorization. The authorization number and a copy of the POC are given to the servicing provider. The case manager provides care instructions to the servicing provider. The servicing provider must bill and receive payment through MMIS.

ADSD uses a Statement of Understanding/Choice form to indicate the recipient's knowledge of their right to choose home and community based services in their home, as opposed to placement in a nursing facility and the provider of their choice. Case managers inform recipients of their right to choose at the time of initial assessment and at monthly contacts.

Review of the Statement of Understanding/Choice is captured on the case file review form for initial assessments and at the time of annual reassessments. Reviews are submitted to quality management to track and trend. The findings are reported at the quarterly quality management meetings for recommendations, remedial action, and improvement strategies.

Trained ADSD staff complete participant experience surveys (PES) with 95/5 random sampling, annually of ongoing waiver recipients which include questions on choice and satisfaction. Participant surveys are submitted to quality management as they are completed to be analyzed for trends and areas of improvement. The information is discussed at the quarterly quality management meetings to identify areas for improvement and develop improvement strategies.

When a potential waiver applicant is referred for service, a LOC determination is completed. If the applicant meets the criteria for nursing facility placement, home and community-based services as an alternative to institutional care are discussed with the applicant and/or his or her designated legal representative. If the applicant prefers institutionalization, the applicant may remain in or be placed in a nursing facility.

After the choices have been explained and prior to enrollment in the waiver, all waiver applicants read (or have read to them) and sign a Statement of Understanding/Choice that includes the following statements:

I may choose and have chosen to receive Home and Community-Based Services in lieu of placement in a long-term-care facility (nursing facility).

I may select the provider of my choice from those who meet Medicaid provider requirements and are willing to contract with the Division of Health Care Financing and Policy.

I may request a hearing from the Division of Health Care Financing and Policy (DHCFP) if I have not been given a choice of Home and Community-Based Services as an alternative to a long-term-care facility placement, if I am denied this service, or if services are reduced, suspended or terminated. A request for a hearing must be received by the DHCFP office within 90 calendar days of the Notice Date, and can be submitted via the internet, telephonically, in person, through other commonly available electronic means, and in writing and signed by the recipient or the recipient's authorized representative. Written requests must be mailed to Nevada Medicaid, 1100 E. William Street, Suite 102, Carson City, NV 89701.

This Statement of Understanding/Choice must be in the recipient's case management file and in the file at the ADSD office for the geographic area in which the participant resides. During the annual review, the DHCFP Quality Assurance Unit verifies that this form has been signed and is in the file.

The DHCFP Medicaid Services Manual (MSM) Chapter 3100 sets forth Medicaid policy regarding Fair Hearings. Pursuant to 42 CFR 431 Subpart E, Nevada Medicaid will provide an opportunity for a fair hearing to any person whose claim for assistance is denied or not acted upon promptly.

In Section 3104 of the Medicaid Services Manual, Nevada Medicaid provides the Fair Hearing process and describes each step of the process and timelines as appropriate, from the beginning of the process to the rendering of a decision. The Medicaid Services Manual Chapter 3100 further describes the process of the disposition of the hearing request; the notification, scheduling, and location of the hearing; program participation upon recipient request pending fair hearing outcome; hearing participation; and hearing preparation and presentation.

Medicaid Services Manual Chapter (MSM) 2200 identifies the following circumstances under which notice must be made to a waiver applicant or participant of an adverse action:

Denial of specific waiver services
Termination of specific waiver services
Reduction of specific waiver Services
Termination of the waiver program

Denied entrance to the waiver due to not meeting the level of care requirement or failure to show a need for one ongoing waiver service

Suspension from the waiver program if recipient is institutionalized less than 60 days Termination of the wait list due to various circumstances

All Notices of Decision contain a statement of the persons hearing rights and how to access the hearing process. Notices of Denial, Suspension, or Termination are generated in DHCFP's Central Office and the recipient is notified.

Individuals are informed of their rights to a fair hearing at the initial home visit and annually thereafter when they are given the recipient rights form. In addition, individuals are notified through the Statement of Understanding of their rights to a fair hearing.

Individuals are provided with a notice of decision for all adverse actions to include denial, termination and reduction. The notice of decision form addresses an individual's right to a fair hearing.

Individuals are provided with a notice of decision for all adverse actions to include denial, termination and reduction. The notice

of decision form addresses an individual's right to a fair hearing. This notice of decision also addresses the individual's choice to continue the services during the hearing process. Case managers and DHCFP hearings staff discusses continue services.

The case manager informs the recipient of their right to a fair hearing and if a service is denied, reduced or terminated they get written notification and steps to take to request a fair hearing.

The Notice of Decision comes from DHCFP and questions can be answered by either the case manager or DHCFP's hearings unit.

Nevada Revised Statutes (NRS) reads as follows: NRS 200.5091 Policy of State. It is the policy of this State to provide for the cooperation of law enforcement officials, courts of competent jurisdiction and all appropriate state agencies providing human services in identifying the abuse, neglect, exploitation, isolation and abandonment of older persons and vulnerable persons through the complete reporting of abuse, neglect, exploitation, isolation and abandonment of older persons and vulnerable persons.

The statute includes an extensive list of persons required to report incidences of abuse, neglect, exploitation, isolation or abandonment, which includes persons who provide medical or social services or supports.

The report must be made to a law enforcement agency as soon as reasonably practicable, but not later than 24 hours after the person knows or has reasonable cause to believe that an older person or vulnerable person has been abused, neglected, exploited, isolated or abandoned. Because of these timeframes, telephone or facsimile reports are accepted by most law enforcement agencies.

Additionally, DHCFP and Aging and Disability Services Division (ADSD) require all direct care providers for the waiver to report all serious occurrences, including those required to be reported to the ADSD Adult Protective Services (APS) and/or law enforcement, including occurrences of suspected abuse, neglect, exploitation and isolation, abandonment as well as falls and injuries requiring medical attention, deaths, unplanned hospital visits, loss of contact, theft and exploitation. The State has implemented a new Serious Occurrence (SOR) database that captures all reports submitted from providers, the public or reported to the Case Managers. The paper form has been turned into an electronic format that is accessible to all providers, public and State staff via the DHCFP's public website and the DHCFP Fiscal Agent's website. Once the SOR is completed and submitted electronically, it will populate SOR which is used as both, a database and a SOR management system. Specific identified staff will be notified when a SOR is received so they can review it, distribute as needed, and work as appropriate. This system will allow an assurance that the SORs are being reported, recorded and responded on a timely basis. This system will also allow the State to collect data more easily for reporting requirements.

The State of Nevada has established mandatory reporting requirements of suspected incidents of Elder Abuse. ADSD and local Law Enforcement are the receivers of such reports. Reports must be made within 24 hours of discovery, identification/suspicion. A completed SOR report/incident report must be made within five (5) working days and maintained in the case file. ADSD have five (5) working days to follow up with the recipient and/or provider on the critical event. The case managers and waiver service providers are mandatory reporters.

Recipient safeguards include initiation of investigation by local law enforcement and/or APS, and provision of protective services to the older and vulnerable persons if they are able and willing to accept them. If the person who is reported to have abused, neglected, exploited, isolated or abandoned an older person or a vulnerable person is the holder of a license or certificate issued pursuant to NRS Chapters 449, 630 to 641B, inclusive, or 654, information contained in the report must be submitted to the Board that issued the license.

The Division of Public and Behavioral Health (DPBH) also receives complaints regarding the facilities they license. ADSD staff received training on how to make appropriate referrals for investigation when events occur that may be considered licensing infractions.

Current waiver providers are expected to report concerns with care supervision and delivery to the case manager under their current contracting language. Reporting includes:

- 1. Suspected physical or verbal abuse;
- 2. Unplanned hospitalization;
- 3. Abuse, neglect, exploitation, isolation, abandonment, or unexpected death of the recipient;
- 4. Theft;
- 5. Sexual harassment or sexual abuse;
- 6. Injuries requiring medical intervention;
- 7. An unsafe working environment;
- 8. Any event which is reported to Adult Protective Services (ages 18 years old and above) or law enforcement agencies;
- 9. Death of the recipient;
- 10. Loss of contact with the recipient for three (3) consecutive scheduled days or;
- 11. Medication errors resulting in injury, hospitalization, medical treatment or death.

12. Elopment of a recipient residing in a Residential Group Home for Seniors or Assisted Living Facility;

ADSD will be notified of any serious occurrence within 24 hours of discovery. ADSD have five (5) working days to follow up with the recipient and/or provider on the critical event. Action as appropriate, including supervisory review, will be taken. Based on the outcome of the analysis,the occurrence will be reported to the oversight agency or law enforcement and the recipient will be offered protective services as appropriate. Serious occurrences will be forwarded to ADSD quality management. The trends of the reports will be reviewed at the Quarterly Management Meetings and program/policy modifications will be recommended if possible.

Instances of abuse, neglect, exploitation, isolation or abandonment alleged to be committed by a Medicaid provider must have an internal investigation by the provider. The provider does provide the final results to the State of how they have addressed the problem.

c. Participant Training and Education. Case managers educate clients regarding reporting requirements and available agency contacts.

Annually-Recipient Rights form is reviewed with and provided to the participant/guardian/family during the in-person assessment and reassessment. The Statement of Understanding is maintained in the recipient's case file which includes a signature acknowledging they received and understand the Recipient Rights form.

The Recipient Rights form includes phone numbers of various agencies and other additional resources on how to report abuse, neglect, and exploitation. The information page is reviewed annually during the reassessment process/annual face-to-face home visit. This information page also includes the names and phone numbers of both the assigned case manager and the case manager supervisor.

d. Responsibility for Review of and Response to Critical Events or Incidents. Reports of abuse, neglect, exploitation, isolation, or abandonment of older and vulnerable persons are made to ADSD, APS Unit, during normal working hours. Reports are investigated by the local office and shall commence within five (5) working days of receiving the report. Investigations are confidential; however, APS does provide the disposition of completed investigations. If an individual wants the results of an investigation; they must contact APS directly for this information. APS informs recipients and their designees of how to contact them during and after the investigation.

For reports outside normal working hours, reports are made to law enforcement. Law enforcement agencies are required to investigate reports of abuse, neglect, exploitation, isolation, or abandonment immediately.

To specifically help ensure the health and welfare of waiver recipients, direct care providers for the waiver are also required to report all serious occurrences to ADSD. If the report is related to any waiver recipients, the supervisor reviews and provides it to the case manager. The case manager reviews the report and determines whether immediate response is called for and, if so, responds immediately. The case manager contacts the recipient, determines confidentiality, required attempts to verify the report and takes appropriate action. If it is determined that immediate response is not necessary, the case manager follows up at the next monthly contact (such as a report of a minor injury or an unplanned hospital visit about which the case manager already received adequate information to determine that it was not a threat to the recipient). ADSD Supervisory staff reviews the adequacy and effectiveness of the case manager's response to reports as a normal part of their supervisory reviews. If requested by the recipient or representative, results of investigation are provided.

Instances of abuse, neglect, exploitation, isolation, or abandonment are referred to APS.

Instances of abuse, neglect, exploitation, isolation or abandonment alleged to be committed by a Medicaid provider must have an internal investigation by the provider. The provider does provide the final results to the State of how they have addressed the problem.

The paper form has been turned into an electronic format that is accessible to all Providers, Public and State staff via the DHCFP public facing website and the DHCFP's Fiscal Agent's website . Once the SOR is completed and submitted electronically it will populate the internal system which is used as both a database and a SOR database Specific identified staff will be notified when a SOR is received so they can review, distribute as needed, and work as appropriate. This system will allow an assurance that the SOR's are being reported, recorded and responded to on a timely basis. This system will also allow the State to collect data more easily for reporting requirements.

- (5) The date on which any unused medication is removed from the facility or destroyed. (b)A record of the medication administered to each resident. The record must include:
- (1) The type of medication administered;
- (2) The date and time that the medication was administered;
- (3) The date and time that a resident refuses, or otherwise misses, an administration of medication; and (4)Instructions for administering the medication to the resident that reflect each current order or prescription of the resident's physician.
- 2. The administrator of the facility shall keep a log of caregivers assigned to administer medications that indicates the shifts during which each caregiver was responsible for assisting in the administration of medication to a resident. This requirement may be met by including on a resident's medication sheet an indication of who assisted the resident in the administration of the medication, if the caregiver can be identified from this indication

NAC449.2742 Administration of medication: Responsibilities of administrator, caregivers and employees of facility. (NRS 449.0302)

- (a) Ensure that a physician, pharmacist or registered nurse who does not have a financial interest in the facility:
- (1)Reviews for accuracy and appropriateness, at least once every 6 months, the regimen of drugs taken by each resident of the facility, including, without limitation, any over-the-counter medications and dietary supplements taken by a resident; and
- (2)Provides a written report of that review to the administrator of the facility.
- (b) Include a copy of each report submitted to the administrator pursuant to paragraph (a) in the file maintained pursuant to NAC 449.2749 for the resident who is the subject of the report.
- (c) Make and maintain a report of any actions that are taken by the caregivers employed by the facility in response to a report submitted pursuant to paragraph (a).
- (d) Develop and maintain a plan for managing the administration of medications at the residential facility, including, without limitation:
- (1) Preventing the use of outdated, damaged or contaminated medications;
- (2) Managing the medications for each resident in a manner which ensures that any prescription medications, over-the-counter medications and nutritional supplements are ordered, filled and refilled in a timely manner to avoid missed dosages;
- (3) Verifying that orders for medications have been accurately transcribed in the record of the medication administered to each resident in accordance with NAC 449.2744;
- (4) Monitoring the administration of medications and the effective use of the records of the medication administered to each resident;
- (5) Ensuring that each caregiver who administers a medication is in compliance with the requirements of subsection 6 of NRS 449.0302 and NAC 449.196;
- (6) Ensuring that each caregiver who administers a medication is adequately supervised;
- (7)Communicating routinely with the prescribing physician or other physician of the resident concerning issues or observations relating to the administration of the medication; and
- (8) Maintaining reference materials relating to medications at the residential facility, including, without limitation, a current drug guide or medication handbook, which must not be more than 2 years old or providing access to websites on the Internet which provide reliable information concerning medications.
- (e) Develop and maintain a training program for caregivers of the residential facility who administer medication to residents, including, without limitation, an initial orientation on the plan for managing medications at the

facility for each new caregiver and an annual training update on the plan.

The administrator shall maintain documentation concerning the provision of the training program and the attendance of caregivers.

- (f) In his or her first year of employment as an administrator of the residential facility, receive, from a program approved by the Bureau, at least 16 hours of training in the management of medication consisting of not less than 12 hours of classroom training and not less than 4 hours of practical training and obtain a certificate acknowledging completion of such training.
- (g) After receiving the initial training required by paragraph (f), receive annually at least 8 hours of training in the management of medication and provide the residential facility with satisfactory evidence of the content of the training and his or her attendance at the training.
- (h) Annually pass an examination relating to the management of medication approved by the Bureau.
- 2. Within 72 hours after the administrator of the facility receives a report submitted pursuant to paragraph (a) of subsection 1, a member of the staff of the facility shall notify the resident's physician of any concerns noted by the person who submitted the report. The report must be reviewed and initialed by the administrator.
- 3. Before assisting a resident in the administration of any medication, including, without limitation, any overthe-counter medication or dietary supplement, a caregiver must obtain written information describing the side effects, possible adverse reactions, contraindications and toxicity of the medication.
- 4. Except as otherwise provided in this subsection, a caregiver shall assist in the administration of medication to a resident if the resident needs the caregiver's assistance. A caregiver may assist the ultimate user of controlled substances or dangerous drugs only if the conditions prescribed in subsection 6 of NRS 449.0302 are met.
- 5. An over-the-counter medication or a dietary supplement may be given to a resident only if the resident's physician has approved the administration of the medication or supplement in writing or the facility is ordered to do so by another physician. The over-the-counter medication or dietary supplement must be administered in accordance with the written instructions of the physician. The administration of over-the-counter medications and dietary supplements must be included in the record required pursuant to paragraph (b) of subsection 1 of NAC 449.2744.
- 6. Except as otherwise provided in this subsection, a medication prescribed by a physician must be administered as prescribed by the physician. If a physician orders a change in the amount or times medication is to be administered to a resident:
- (a) The caregiver responsible for assisting in the administration of the medication shall:
- (1) Comply with the order;
- (2) Indicate on the container of the medication that a change has occurred; and
- (3) Note the change in the record maintained pursuant to paragraph (b) of subsection 1 of NAC 449.2744; (b)Within 5 days after the change is ordered, a copy of the order or prescription signed by the physician must be included in the record maintained pursuant to paragraph (b) of subsection 1 of NAC 449.2744; and
- (c) If the label prepared by a pharmacist does not match the order or prescription written by a physician, the physician, registered nurse or pharmacist must interpret that order or prescription and, within 5 days after the change is ordered, the interpretation must be included in the record maintained pursuant to paragraph (b) of subsection 1 of NAC 449.2744.
- 7. If a resident refuses, or otherwise misses, an administration of medication, a physician must be notified within 12 hours after the dose is refused or missed.
- 8. An employee of a residential facility shall not draw medication into a syringe or administer an injection unless authorized by law to do so.
- 9. If the medication of a resident is discontinued, the expiration date of the medication of a resident has passed, or a resident who has been discharged from the facility does not claim the medication, an employee of a residential facility shall destroy the medication, by an acceptable method of destruction, in the presence of a witness and note the destruction of the medication in the record maintained pursuant to NAC 449.2744.
- 10. The administrator of a facility is responsible for any assistance provided to a resident of the residential facility in the administration of medication, including, without limitation, ensuring that all medication is administered in accordance with the provisions of this section.

Each facility shall have and implement policies and procedures that minimize errors in the administration of drugs. The medical director of the facility and the pharmacist who is responsible for the pharmacy service shall approve the policies and procedures.

Errors in administering a drug, adverse reactions by a client to a drug and incompatibilities between a drug and a

client must be immediately reported to the attending physician of the client.

If an accident or incident occurs at a facility, including, without limitation, any error in providing medication to a patient of the facility or any adverse reaction of a patient to a drug administered to the patient at the facility, the facility shall immediately prepare a written record of the accident or incident. A written record prepared pursuant to this subsection must be maintained by the facility and be made available for review by the BHCQC.

Additionally, medication errors resulting in injury, hospitalization, medical treatment or death would require that a serious occurrence report be submitted electronically to the Serious Occurrence Reporting system within 24 hours of discovery. The ADSD case manager will follow up as indicated and the supervisor will review for appropriateness.

Medication management is not a component of a waiver service. CM review medication logs on group home residents. If a medication issue is identified in a private home setting the MD is notified with a possible Home Health referral. In addition, all med errors are sent to HCQC via an inter-agency ALERT memo. All divisions work together to ensure remediation efforts are taken when necessary.

This can include involving APS/Ombudsmen staff until a group home has on site staff to manage needs to ensure health, safety and welfare.

- Providers are required to self report medication errors.
- Case managers check medication logs during in person contacts and as reported to ADSD. ADSD follows-up within 5 working days.
- Recipients may report missed doses or other issues to their case manager.

The HCQC is responsible for oversight and follow up of medication management for providers licensed as a residential facility for groups. The ADSD staff review medication logs and notify HCQC in the form of an Alert Memorandum if issues are identified.

- a) and b) NAC 449.2738 Review of medical condition of resident; relocation or transfer of resident having certain medical needs or conditions. (NRS 449.0302)
- 1. If, after conducting an inspection or investigation of a residential facility, the Bureau determines that it is necessary to review the medical condition of a resident, the Bureau shall inform the administrator of the facility of the need for the review and the information the facility is required to submit to the Bureau to assist in the performance of the review. The administrator shall, within a period prescribed by the Bureau, provide to the Bureau.
- (a) The assessments made by physicians concerning the physical and mental condition of the resident; and
- (b) Copies of prescriptions for medication or orders of physicians for services or equipment necessary to provide care for the resident.
- 2. If the Bureau or the resident's physician determines that the facility is prohibited from caring for the resident pursuant to NAC 449.271 to 449.2734, inclusive, or is unable to care for the resident in the proper manner, the administrator of the facility must be notified of that determination. Upon receipt of such a notification, the administrator shall, within a period prescribed by the Bureau, submit a plan to the Bureau for the safe and appropriate relocation of the resident pursuant to NRS 449.700 to a place where the proper care will be provided.
- 3. If an inspection or investigation reveals that the conditions at a residential facility may immediately jeopardize the health and safety of a resident, the administrator of the facility shall, as soon as practicable, ensure that the resident is transferred to a facility which is capable of properly providing for his care.

NAC449.2748 Medication: Storage; duties upon discharge, transfer and return of resident. (NRS 449.0302) 1.Medication, including, without limitation, any over-the-counter medication, stored at a residential facility must be stored in a locked area that is cool and dry. The caregivers employed by the facility shall ensure that any medication or medical or diagnostic equipment that may be misused or appropriated by a resident or any other unauthorized person is protected. Medications for external use only must be kept in a locked area separate from other medications. A resident who is capable of administering medication to himself or herself without supervision may keep the resident's medication in his or her room if the medication is kept in a locked container for which the facility has been provided a key.

- 2. Medication stored in a refrigerator, including, without limitation, any over-the-counter medication, must be kept in a locked box unless the refrigerator is locked or is located in a locked room.
- 3. Medication, including, without limitation, any over-the-counter medication or dietary supplement, must be: (a)Plainly labeled as to its contents, the name of the resident for whom it is prescribed and the name of the prescribing physician; and
- (b)Kept in its original container until it is administered.
- 4. Except as otherwise provided in subsection 5, when a resident is discharged or transferred from a residential facility, all medications prescribed for the resident must be provided to the resident or to the facility to which he or she is transferred.
- 5. If a resident is transferred to a hospital or skilled nursing facility, the residential facility shall hold the resident's medications until the resident returns or for 30 days after the transfer, whichever is less, unless the hospital or skilled nursing facility requests the residential facility to provide the hospital or skilled nursing facility with the medications. If the resident does not return within 30 days after the transfer, the residential facility shall promptly dispose of any remaining medications. Upon the return of the resident from the hospital or skilled nursing facility, the residential facility shall, if there has been any change in the resident's medication regimen:
- (a) Contact a physician, within 24 hours after the resident returns, to clarify the change; and
- (b) Document the physician contact in the record maintained pursuant to paragraph (b) of subsection 1 of NAC 449.2744.
- (c) Medication administration is regulated by HCQC. If a resident refuses, or otherwise misses, an administration of medication, a physician must be notified within 12 hours after the dose is refused or missed.

Each facility shall have and implement policies and procedures that minimize errors in the administration of drugs. The medical director of the facility and the pharmacist who is responsible for the pharmacy service shall approve the policies and procedures.

Errors in administering a drug, adverse reactions by a client to a drug and incompatibilities between a drug and a client must be immediately reported to the attending physician of the client.

If an accident or incident occurs at a facility, including, without limitation, any error in providing medication to a patient of the facility or any adverse reaction of a patient to a drug administered to the patient at the facility, the facility shall immediately prepare a written record of the accident or incident. A written record prepared pursuant to this subsection must be maintained by the facility and be made available for review by the HCQC.

To be licensed as a residential facility for groups, caregivers, owners are required to obtain 16 hours of training in medication management consisting of not less than 12 hours of classroom training and not less than 4 hours of practical training and must obtain a certificate of completion.

Any medication errors resulting in injury, hospitalization, medical treatment or death would require that a serious occurrence report be submitted to the ADSD case manager by telephone/fax within 24 hours of discovery. A completed SOR form report must be made within five (5) working days and maintained in the agency's recipient record. The case manager will follow up as indicated and the supervisor will review for appropriateness as well as referrals are made to HCQC.

ADSD submits SOR report to DHCFP on a quarterly basis.

Residential Group home staff that meet qualifications to provide oversight and have had the training required to participate in medication administration provide medication management.

Training requirements are part of the NAC:

Administrators and caregivers of the residential facility, receive, from a program approved by the Bureau, at least 16 hours of training in the management of medication consisting of not less than 12 hours of classroom training and not less than 4 hours of practical training and obtain a certificate acknowledging completion of such training.

After receiving the initial training required, they must receive annually at least 8 hours of training in the management of medication and provide the residential facility with satisfactory evidence of the content of the training and his or her attendance at the training.

Annually pass an examination relating to the management of medication approved by the Bureau.

Administrators have to complete initial training within the first year, and caregivers must complete initial training prior to assisting any recipient with medication administration.

ADSD does not provide training for medication deficiencies as this fall under HCQC.

Providers are required to report all medication errors through the Serious Occurrence Process. All errors are tracked and trended, by recipient and by provider, by ADSD. ADSD is not the regulatory agency, so all med errors are sent to HCQC via an inter-agency ALERT memo. All divisions work together to ensure remediation efforts are taken when necessary. This can include involving APS/Ombudsmen staff until a group home has on site staff to manage needs to ensure health, safety and welfare.

HCQC conducts investigations, imposes monetary fines, and may require corrective action plans for substantiated reports. If all fails, HCQC may pull the license.

Per NRS 200.5093, policy that every employee adheres to reporting instances of abuse, neglect, exploitation, isolation, or abandonment to the APS unit. Each ADSD employee signs a Policy for Reporting Older or vulnerable persons Abuse form indicating their responsibility to report abuse, neglect, exploitation, isolation, or abandonment

Case managers seek to prevent instances of abuse, neglect, exploitation, isolation, or abandonment and ensure the health, welfare and safety via monthly contacts with recipients.

Supervisory staff reviews a sample size of ongoing case files producing a probability of 95/5 confidence level which identifies monthly contact, concerns, needs, follow-up action, and waiver satisfaction. These reviews are captured on the Case File Review Form and submitted to ADSD QA as they are completed. ADSD QA reports this data at quarterly quality management meeting for review and recommendations.

Case managers report concerns of abuse, neglect, exploitation, isolation, or abandonment to the APS unit. Case managers and providers are also responsible for completing DHCFPs electronic Serious Occurrence Report (SOR) form. Upon receipt of the SOR, case managers take appropriate follow-up action regarding the occurrence. The SOR database tracks and trends all reported and followed up incident reports. ADSD QA monitors the SOR database, generates report upon request and updates are provided during the quarterly Management Meetings and program/policy modifications will be recommended if possible.

Safeguard regarding unauthorized restraints and seclusion - During in-person on-site reviews, the Case Manager or ADSD QA will conduct an environmental review which includes looking for unauthorized restraints/isolation. Any unauthorized restraints or isolation are reported to APS and Law Enforcement, entered in the SOR database under abuse or isolation and followed-up by CM. Report is submitted to DHCFP quarterly.

Additionally, licensed residential facility for groups are also being monitored by HCQC for unauthorized restraints or seclusion and if Medicaid recipient is the victim, this is also reported to DHCFP and ADSD for appropriate and immediate placement to another facility.

Case managers provide a copy of the HCBW Recipient Rights to all individuals at the initial and annual home visits. The Recipient Rights includes the following statements: the right to not to be physically, sexually, or otherwise abused, not to be neglected, not to be exploited, not to be abandoned and not to be isolated. In addition, this form provides contact information for who to contact, if they suspect they are being abused, neglected, isolated, exploited or abandoned. This form also includes the name and contact number of the case manager and the case manager supervisor so recipients can call if there are issues. Case managers are responsible for addressing issues and providing referrals if applicable. In some cases, a referral to another state agency, provider agency, or law enforcement is the appropriate action.

ADSD waiver staff coordinate and consult with APS staff on cases with suspected abuse, neglect, exploitation, isolation, or abandonment. APS staff performs provider and staff training on mandated reporting and elder issues. If trends are identified, they will be reported to ADSD QA for resolution/remediation.

Education is completed to verify that providers are aware of the serious occurrence policy and that they have the information on how to submit an electronic SOR through the link provided on the DHCFP and/or the DHCFP's Fiscal Agents website. Reviewers also verify that serious occurrences are being completed, followed up on, and kept on file. Supervisors or QA staff review time frames for reporting serious occurrences. If a provider is not in compliance, education is offered and provided to the provider by case managers or supervisory staff.

Appendix H: Quality Improvement Strategy (1 of 3)

Under §1915(c) of the Social Security Act and 42 CFR §441.302, the approval of an HCBS waiver requires that CMS determine that the state has made satisfactory assurances concerning the protection of participant health and welfare, financial accountability and other elements of waiver operations. Renewal of an existing waiver is contingent upon review by CMS and a finding by CMS that the assurances have been met. The State of Nevada is a large rural state that consists of two major urban areas that are over 400 miles apart. They are Las Vegas located in the southern Clark County and Reno located in the northern Washoe County. Rural Nevada covers over 90,000 square miles. Aging and Disability Services Division (ADSD) is responsible for operating the Waiver for the Frail Elderly.

The ADSD offices are located in Carson City, Reno, Las Vegas and Elko. The Quality Assurance Units are located in Las Vegas and Carson City and reports to the ADSD Quality Assurance Manager.

ADSD is committed to improving its quality management system and has allocated a full time quality assurance position to this waiver program which has been filled since 2006. There is also special projects staff in the Carson City office and Las Vegas office dedicated to quality initiatives. ADSD has participated in and operated a Quality Management Committee since January 2004 in order to specifically address CMS quality assurance components and improve program performance. ADSD quality management system continues to evolve and refine monitoring tools and processes to better reflect CMS assurance components.

Statewide Quality Management Committee:

At the center of the ADSDs quality management system is the Statewide Quality Management Committee (QM) which meets quarterly. This team is composed of ADSDs Quality Assurance (QA), the Chief of Community Based Care, district managers, supervisors, and case managers. The QM committee has provider representatives. DHCFP participates in the QM meetings with members of the Quality Assurance Unit and the Waiver Operations Unit. The purpose of the QM committee is to coordinate quality assurance and quality improvement activities across the state. The committee monitors performance statewide by reviewing performance measures based on the data gathered in the previous quarter for the six quality assurances, which ensures that discovery processes for the waiver program are carried out consistently and reliably. In its analysis of statewide data, the committee identifies strategies for improvement or remediation to be implemented statewide.

The purpose of the QM meeting is to:

- Identify waiver goals;
- Remediate issues and problems through policy development and clarification;
- · Review program data for trending;
- Identify staff training needs and program changes;
- · Discuss and identify program improvements; and
- · Set priorities for system improvement.

The QA Committee is responsible for:

- Updating of waiver processes to specifically address CMS assurance components;
- Standardizing education, training and quality systems;
- Monitoring the results of supervisory level monitoring and designing statewide reports;
- Improving program performance and ensuring efficiency; and
- Implementation of waiver assurance monitoring for the health and welfare of recipients.
- In some cases, a work group may be established to identify possible solutions to needed improvements.

Documentation of meeting minutes, decisions, and agreements are maintained.

Quality improvement goals are identified in the QM committee as well and progress is discussed at each meeting. In some cases, work group meet in between quarterly meetings and progress is reported at each meeting.

ADSDs Quality Management Unit is made up of one quality assurance specialist, a social worker allocated part time in the north and south, a Health Care Coordinator 3, a management analyst 1 and one administrative assistant. They are responsible for developing reports on performance measures that are shared with the QM committee quarterly.QM staff also work with the special projects team to track and trend data and ensure QM initiatives are implemented. Data and trends are discussed as well as remediation strategies and future plans. DHCFP quality assurance representatives use this opportunity to provide program oversight, make inquiries, or ask for additional information.

ADSD Supervisor Meetings

ADSD supervisors meet monthly to discuss program operations to include policy and procedure. The quality assurance specialist presents an update on quality management functions having to do with reporting requirements for the District Offices to newly implemented processes. Supervisors have that opportunity to seek clarification on data collection methods and processes for quality management purposes.

DHCFP Annual Reviews

DHCFP Quality Assurance (QA) Unit conducts annual reviews of case files, financial, and recipient survey called Participant Experience Survey (PES). Additionally, QA unit leads Quality Improvement (QI)meetings on a monthly basis to go over case file review results of any assurances and sub-assurances performance measures that fall below the 86% threshold and ways to remediate and how to mitigate future errors are discussed. The annual reviews and QI meetings are for both Frail and Elderly Waiver (FE Waiver) and Physically Disabled Waiver (PD Waiver). This consolidated review and QI meetings stemmed from the previous approved FE and PD Waivers.

Participants of the QI meetings consist of ADSD staff (supervisors, chief and QA) and DHCFP QA and LTSS units.

b. System Design Changes

The QM committee is the main body for evaluating information statewide. It is also the committee that develops new data collection tools and processes. The team has begun to develop integrated data systems that draw information from a number of data sources.

Data is collected in a variety of ways. It is collected from Initial Assessment Reviews, Ongoing Case File Reviews, Level of Care Reviews, Serious Occurrence Reporting and Participant Experience Surveys. Reports are created and shared quarterly at the QM committee meetings. Going forward, QM plans to place more emphasis on analysis of trends. The QM Committee minutes document the data reviewed, improvement strategies developed, and the entity responsible for implementation statewide.

ADSD utilizes a web-based case management system called Social Assistance Management Software (SAMS). This system has reporting capabilities that are under development with the current database. There are numerous reporting capabilities in SAMS system which include: QM Open Cases Quarterly for sampling, QM Level of Care Compare Report Monthly to evaluate timelines, QM Plan of Care Compare Report - Monthly to evaluate timeliness, QM Level Of Care Timeliness Report Monthly to evaluate timelines amount of time for a new referral to obtain a Level of Care screening, QM Case Processing Timeliness Report Monthly to evaluate case processing time from pending to approved, QM APS Report Quarterly to review waiver clients who have received an APS referral and if it was substantiated or unsubstantiated, and QM Annual Provider Review Report Quarterly to evaluate timeliness of ADSD contracted providers site visits.

DHCFP participates in the quarterly QM meetings, which is the forum for the state to share information on improvement strategies that are being implemented based on the analysis of the data shown in the reports.

Quality management is a system that changes and improves over time. The process of data analysis, setting goals, monitoring outcomes and identifying problem areas leads to continual adjustment of the quality management strategy. The QM Manager is responsible for updating the quality management strategy. The process is to review and update the strategy annually. The quality management strategy is posted for every employee of ADSD to view. The strategy is shared with DHCFP.

The Quarterly Quality Management Meetings are used to evaluate the quality management strategy on an ongoing basis. The quality manager uses feedback from the quarterly meetings, as well as information from the current processes to evaluate the effectiveness, efficiency and appropriateness of the quality management system and update the system on an as needed basis. Evidentiary reports, annual review findings, and Plans of Improvement are utilized to evaluate and set priorities.

FINANCIAL INTEGRITY

The NV Medicaid Management Information System (MMIS) went through modernization and went live on February 2, 2019 now called Interchange (iC). The Interchange system increases efficiency in enrolling Medicaid providers, authorizing services, faster processing providers claims, and has a built-in Medically Unlikely Edit (MUE). Interchange claims processing system identifies the provider, authorized services, and units of service for each recipient. Interchange is linked to DWSS/NOMADS eligibility system. Interchange has a built-in edit which maps the claims to eligible waiver recipient, active waiver provider and prior authorization. If Interchange detects errors, claims are automatically denied. DHCFP LTSS unit works closely with Medicaid waiver providers and DHCFP Business Process Management Unit (BPMU) in resolving any unpaid or denied claims. Further, the Interchange system maintains records of incurred and paid claims, both the recipient and the provider files and provides data for the CMS 64 and CMS 372 reports.

Medicaid waiver provider agencies are not required to secure an independent review of financial statements. All claims are submitted electronically through Interchange. In addition to the Interchange audit, DHCFP QA staff completes annual financial review. The objective of this review is to confirm the accuracy of provider payments made by examining claims paid and comparing those claims with recipient files, Plans of Care, provider qualifications, waiver requirements, and waiver policy. ADSD also completes an annual financial review on 10% of recipients during the year.

The financial review utilizes the statewide random sample of recipients selected for program review. A list of claims paid is produced from the Interchange for each sample case for all waiver services for one chosen month. A sample month is randomly selected for each recipient who is part of the sample. All waiver claims for that sample month for that recipient are examined, in conjunction with the POC and daily record documentation. Results of financial reviews are reported to CMS through annual 372 reporting.

If the outcome of the financial review resulted in a possible overpayment to providers, this gets referred to DHCFP Surveillance and Utilization Review Unit (SURS) or the Medicaid Fraud Control Unit for further investigation and possible recoupment.

The State has in place a Quality Improvement Committee which analyzes any noted areas and works on improvement for those areas during the year, and up to the next review. This committee includes DHCFP LTSS and QA units, and ADSD staff which consist of Community Based Care chief, supervisors and QA. This committee assesses the seriousness and pervasiveness of the problems, identifies goals to remediate issues and problems through policy development, policy clarification, system and program changes, staff training and other remedies, and follows up on remediation progress.

b. Methods for Remediation/Fixing Individual Problems

ADSD internally validates billing and reviews billing workbooks for case management. Factors reviewed include recipients, dates of service, authorization, procedure codes, provider number, eligibility effective date, modifier, and rates. The review is based on claims history reports generated from Interchange. DHCFP staff also completes an annual review which includes financial integrity.

ADSD supervisor staff reviews a sample of ongoing case files for appropriateness of administrative claims versus direct service case management and to verify the correct units are billed. If this area is found to be deficient, supervisors address this individually with case managers to identify areas in needing improvement and ensure corrections are made.

DHCFP QA and ADSD supervisory staff reviews a random sample of claims paid through the Interchange system for a months of waiver services. The purpose of the financial review is to evaluate waiver payments. DHCFP evaluates the services received by the recipients to ensure they are appropriate for the waiver. If providers have billing issues identified during the review they will be required to correct the issue and outline a corrective action plan going forward.

If claims are discover to be incorrect, a referral is made to the Surveillance and Utilization Review Unit (SUR) within DHCFP. This unit investigates under/over payments and will recoup funds from providers if overpayment occurs. SUR unit also provides education to providers regarding policies for proper billing and rules and regulations for Medicaid providers. In addition, DHCFP's fiscal agent provides training to new providers on billing procedures and upon request of active Medicaid providers who have difficulty submitting clean claims electronically. If provider training efforts fail, DHCFP may suspend the provider from accepting new Medicaid recipients and request a corrective action plan.

If there are errors found within Interchange during the annual review, there is a mechanism in place to correct these issues. The errors that have been noted in the past include incorrect rates, payments edits that are not functioning, or payment edits that need to be included so claims pay appropriately. When these types of errors are noted, a form called a Production Discrepancy Report (PDR) is completed which identifies the nature of the problem. The PDR is submitted to the fiscal agent for a Scope of Work which outlines the amount of time and cost of fix. DHCFP Information Technology staff approves any and all work related to Interchange.

State laws, regulations, and policies referenced in the description are available upon request to CMS through the Medicaid agency or the operating agency (if applicable).

The Division of Health Care Financing and Policy (DHCFP) determines all rates. Documentation of the assumptions, inputs, rate development methodology, and fee-schedule payment rates are maintained by the DHCFP. The rate determinations are done in house with programmatic staff, stakeholders as well as at the direction of the Nevada Legislature. Oversight of the rate determination process is done at the Administrative level of the DHCFP. Waiver reimbursement rates are available to all waiver participants at the DHCFP's website, listed by provider type at: http://dhcfp.nv.gov/Resources/Rates/FeeSchedules/ - Provider Types 48, 57 and 59 Waiver for Frail Elderly.

Effective January 1, 2018, Chapter 422 of the Nevada Revised Statutes (NRS) requires review of sufficiency of all Nevada Medicaid services scheduled for review no less than every 4 years. Details of the schedule are currently under review.

As a requirement of the Frail Elderly (FE) Waiver Renewal, the DHCFP initiated a complete review of waiver service rates and documentation of rate methodologies in October of 2019 and completed in February of 2020. This review was required due to lack of detailed documented historical data concerning waiver rates and methodologies.

Previous FE Waiver renewals and subsequent amendments referenced methodologies developed from a comprehensive rate study conducted by EP&P for the State of Nevada and completed in 2002. The inputs and assumptions outlined in the 2002 rate study are updated to the most currently available reference data and the resulting rates are benchmarked against other states with similar waiver services, Nevada Medicaid State Plan service rates, Nevada Medicaid Agency staff, provider input from a Wage and Benefit Survey, and data from the fiscal reporting system.

The 2019 rate review included an electronic wage and benefit survey of waiver service providers with opportunity for providers to complete a paper-based survey. Providers were given a full four months to respond before the survey was closed and the results were analyzed and compiled. The respondent provider pool represented 17% of FE waiver providers who provided waiver services to 21% of FE waiver recipients. The survey was determined to return enough reliable data regarding wages, full and part-time status of direct caregivers, averages for travel and documentation time, and provided benefits to inform the rate review study. Also, interstate comparison of adjoining states and other states with similar waiver services was used for the rate review, researching a total of 6 states.

Nevada's FE Waiver Fee Schedule services are grouped by category and rate methodology. An established fee-schedule or Fee-for-Service (FFS) reimbursement type is utilized by Nevada Medicaid for the FE Waiver, paying uniform rates across all providers. Rates for the HCPCS waiver billing codes are developed utilizing a defined rate methodology structured to reflect service delivery provisions, inputs and cost assumptions. The resultant rates are scaled to the appropriate unit (per 15 minutes, per diem and maximum yearly amount). Rates are compared to other states with similar services, similar state plan and waiver services, as well as provider surveys, input from Nevada Medicaid operating agency staff, and data from provider enrollment and fiscal reporting system. Nevada compared services with Arizona Home and Community Based Services, Idaho Home and Community Based Services, Utah's Aging Waiver (adjoining states), as well as Ohio's Home and Community Based Services, Colorado's Home and Community Based Services, and Indiana Division of Aging HCBS Waiver. All services were compared where at least 2 other states had comparable rates.

Enrollment statistics (2014-2019) show steady increase in new FE waiver providers each year, averaging 5.70%, and a total increase of 24.1% over 5 years. This steady increase in provider capacity indicates the rates are sufficient to attract new providers into the market. The State believes these rates are sufficient to enlist enough providers to ensure access to services for recipients while still being consistent with efficiency, economy, and quality of services. The Rates Unit requested and reviewed records and invoices for service delivery for prior years (2017 – 2018). The records confirmed standardized bid and provider work assignment processes were in place for these services. The caseworkers were asked if there were problems accessing these services or finding providers and indicated providers pools and funds were enough to provide recipients with needed waiver services.

Direct Care Services

Fee-for-Service Direct Care Rate Methodology

Direct Care Waiver Services include:

S5120 - Chore Services

S5130 - Homemaker

S5135 – Adult Companion Services

S5150 – Respite (15 minutes)

S5151 – Respite (per diem)

The rate model is developed from an hourly base wage and increased to reflect service definitions, provider requirements, operational service delivery and administrative considerations.

The following elements are used to determine the rates:

- 1. Wage information is taken from provider surveys and compared to wages for similar services in other states, as well as wages identified by Medicaid staff as comparable to similar State Plan Services.
- 2. Employee related expenses (ERE) percentage of 27% is based on input from Medicaid Staff and approved State Plan direct care service methodologies. It includes paid vacation, paid sick leave, holiday pay, health insurance, life insurance, disability, workers compensation, and legally required payroll taxes.
- 3. Productivity adjustment factor accounts for non-billable time spent by staff. This includes the time for staff to complete required documentation and record keeping, and average travel time reported in survey. Productivity assumptions are based on input from waiver policy staff and provider survey.

Non-billable time is calculated with the assumption that during an 8-hour day, a waiver service provider will spend 30 minutes documenting the services provided to recipients and will spend about 48 minutes (from 2018 provider survey) traveling between recipients. This is time spent outside of providing direct care services and cannot be billed. This nonbillable time is subtracted from the total 8 hours, equaling 6.7 hours of "billable" time. A factor is derived by dividing the total hours by the billable hours and is "factored" back into (and increasing) by multiplying the ERE-adjusted hourly wage by the productivity factor.

4. Administrative overhead of 10% is the percentage of service costs allowed by Nevada Medicaid's State Plan for non-direct care activities including insurance, administrative staff, operations and management activities and office supplies. This does not exceed the percentage allowable by state law.

The following steps are used to determine the rates:

- 1. The State will use the hourly base wage for each service.
- 2. The hourly amount is increased by the 27% ERE.
- 3. A productivity factor is applied to the hourly compensation increased by the ERE calculated in Item 2.
- 4. Administrative overhead (10%) is applied to the adjusted hourly rate. (Item 3).
- 5. Total hourly rate is the sum of the adjusted hourly rate and increased by the administrative overhead (Item 4).
- 6. Total hourly rate is scaled to the proper unit based on the unit of service.

The rates are compared to other states with similar waiver services, data from a Provider Wage and Benefit Survey, as well as similar state plan services. Documentation of the assumptions used, rate development methodology and fee schedule payment rates will be maintained by DHCFP.

Rates that are active in the system as of December 1, 2020 will be reduced by 6% until June 30, 2021. Rates will be restored to the pre-reduction amount by July 1, 2021. Rates calculated after July 1, 2021 will be calculated using the above methodology.

PERS Install and PERS Monthly - The rate calculation for PERS is based on the actual cost billed to ADSD by the service provider in 2002. The rates for one-time installation charge and subsequent monthly amount were set in 2002, reviewed in 2014, and in 2018. Rates were comparable to those of other states with similar services and found to be consistent with efficiency, economy and quality of services. These rates will be reviewed in the future according to the 2018 legislated rate review schedule currently in development.

In 2014, a national average review of "Medical Alert Systems" compared Nevada's PERS installation of \$45.00 and monthly charges of \$40.00 to Life Station, Life Alert and Medical Guardian, which averaged \$42.27. At that time, Nevada's rates were also compared to Utah, Idaho and Montana's rates for PERS. The interstate average rate for installation charges equaled 65.52, 30% higher than Nevada's rate of 45.00. Nevada's monthly charge of 40.00 was 40%

lower than the Interstate average of 66.00. The 2018 Interstate comparison review shows the gap between Nevada's rates and interstate comparison has shrunk to approximately 15%.

Waiver Services other than Case Management:

Providers direct bill DHCFP's fiscal agent by submitting an electronic bill through Nevada's Medicaid Management Information System (MMIS). This is true of both public and private providers. Billings do not flow through any intermediary other than the DHCFP's fiscal agent.

The MMIS adjudicates claims by:

- 1. Verifying recipient eligibility.
- 2. Verification of prior authorization.

The provider is expected to:

- 1. Verify eligibility monthly.
- 2. Submit claims weekly or monthly.
- 3. Submit claims directly through the MMIS system.

MMIS has a series of edits which verifies name, Medicaid number, prior authorization, and the number of units of service authorized. If the claim fails just one of these areas, the claim will deny. The provider must resubmit claims with the correct information. There is an edit in the system which verifies providers do not receive reimbursement over what is authorized. Provider claims are stored in a data warehouse and can be accessed through reports.

Case Management:

Case management is not prior authorized and it is provided on an as needed basis. DHCFP has a Time Tracking System in place which allows case managers to track administrative activities as Waiver Administration and direct services activities as Medical Case Management. Each case manager has a billing work book and these workbooks must match time tracking. Supervisors review a representative sample of case file reviews monthly in which this area is included.

Administrative activities and direct service activities are split up as follows:

Administrative activities are time tracked based on the approved cost allocation plan. Those activities include:

- 1. Intake referral;
- 2. Facilitating Medicaid eligibility, which may include assistance with the Medical Assistance for the Aged, Blind and Disabled (MAABD) application and obtaining documents required for eligibility determination;
- 3. Preliminary and ongoing assessments, evaluations and completion of forms required for service eligibility:
- 4. Request form for a Notice of Decision (NOD) when a waiver application is denied;
- 5. Coordination of care and services to collaborate in discharge planning to transition applicants from facilities;
- 6. Documentation for case files prior to eligibility;
- 7. Case closure activities upon termination of service eligibility;
- 8. Outreach activities to educate recipients or potential recipients on how to enter into care through a Medicaid Program;
- 9. Communication of the POC to all affected providers;
- 10. Completion of prior authorization form prior to submission into the Medicaid Management Information System (MMIS).
- 11. Travel time for all home visits

ADSD bills administrative activities based on the approved cost allocation plan through DHCFP fiscal unit.

Direct Services:

- 1. Identification of resources and assisting recipients in locating and gaining access to waiver services, as well as needed medical, social, educational and other services regardless of the funding source;

Case management expenditures are based on actual expenditures and an approved cost allocation plan (CAP). DHCFP approves the CAP. Since these services are billed quarterly after ADSD incurs or pays the cost, there is no interim rate established through a cost report nor are these costs trued up or settled at the end of each year. The rates for public case management are the same for all providers which are state employees and are posted on DHCFP's website under Rates and Cost Containment, Provider Type 48.

The claims processing subsystem then produces fully adjudicated payment requests which are then selected by the financial subsystem for check writing and other financial processing.

During the 76th Legislative Session, SB 485 was passed which amended the counties responsibility to pay the State's Share of expenditures for indigents who are institutionalized with income at 156% to 300% of the Federal Benefit Rate (FBR). The bill amended this population lowering the FBR to an amount prescribed annually by the Director and included the waiver population within the same income limits. The FBR was lowered to 142%.

The counties reimburse these expenditures through property taxes collected. This is not a CPE mechanism as the counties are not providing the services to these recipients. This is a reimbursement of expenditures in which the counties are responsible to pay through property taxes collected. The expenditures include waiver and state plan services provided by private community providers.

DHCFP obtains those funds from the counties by invoicing each county, monthly, based on projected costs for the recipients the county is responsible for. A reconciliation is completed each quarter.

DHCFP updated the contracts of all 17 Nevada counties in 2013 to state "payments made by the County shall be derived from general county tax revenues or other general revenues of the County".

NV used the ARIMA (AR-Autoregressive, I-Integrated, MA-Moving Average) Model to calculate the projected unduplicated participants count using the actual unduplicated participants from 372 reports WY 7/1/2014-6/30/2018 as the baseline, and factors in the state's population growth and employment numbers. According to the model, the average estimated growth rate of 92 is added to each WYs 2-4.

Users per waiver service:

Using the 5 year 372 reports (WY 2014-2018): 1) the estimated percentage of users was calculated by dividing the number of participants for each waiver service to the total number of waiver participants for each waiver year; 2) the percentage of users was averaged out across the 5 years; 3) the average percentage of projected unduplicated count is used for the estimated number of users per waiver service per year.

As for the Augmented Personal Care (APC) Service Level (SL) 4 (U4), this service was added in April 2019. In April 2019 NV submitted the FE amendment to add a new service level to APC and was approved by CMS. For this FE renewal, there is no sufficient data for APC SL4 and therefore, as indicated in the FE amendment, the estimation for the number of users will be 10% of projected unduplicated count each waiver year. As the state gets more data, the FE waiver will be amended to reflect consistent calculation as that of other FE waiver APC SLs 1-3.

Units per user:

Using the 5 year 372 reports (WY 2014-2018), the estimated units per user was calculated by dividing the service count per participant for each waiver service to the number of waiver participants for each waiver service; then averaged out across 5 years.

Average cost per unit:

Cost per unit is based on the rates that were established in 2002, however, some services received rate increase such as APC levels 1-4 of 15% and Adult Day Care Service had an increased of 5%. The increase rates of 15% and 5% were approved by the NV State Legislature effective July 1, 2017. The DHCFP Administration reviewed and proposed the increase rates to the NV Legislature based on public comments and fiscal budget. With this renewal, a new rate methodology is being introduced and will be utilized upon approval from CMS.

Although, other state plan health care services are included in the calculation of Factor D', historical data shows a downward slope in growth. Based on the actual expenditures from 372 reports for WYs 2014-2018, the average growth rate is -0.3%, which was used to determine the Factor D' for this renewal WYI, using WY 2018 as the baseline.
