

Diabetes Prevalence

Among the US population overall in 2018:


- 34.2 million people of all ages—or 10.5% of the US population—had diabetes
- 34.1 million adults aged 18 years or older—or 13.0% of all US adults—had diabetes
- The percentage of adults with diabetes increased with age, reaching 26.8% among those aged 65 years or older



Diabetes Prevalence

The American Diabetes Association indicates that type 2 diabetes accounts for 90% to 95% of all diabetes cases.

Since 2013, diabetes in Nevada increased 21% from 8.9% to 11.2% in adults

Visits to dentist or dental clinic among adults aged >= 18 years with diagnosed diabetes




Figure 36 - Nevada Adults - How Many Permanent Teeth Removed due to Tooth Decay or Gum Disease 2012 & 2014 Pooled



Aligning Methods to Effect Change

Issue: Lack of Medicaid dental benefits

Solution: Expansion of Medicaid dental benefits for diabetic adults and improvement in overall health. Leading to further expansion of dental benefits in subsequent years.

Mechanism: Legislation and Waiver

Goal: Innovative patient centered care to improve overall patient health and reallocate medical funding for dental treatment.

"In the long run, preventing diabetic complications not only saves lives, but it improves public health and saves public money," Dr. Michael Bush, an endocrinologist in Calif., and president of the California chapter of the American Association of Clinical Endocrinologists.



Assembly Bill 223: NRS422.27247 Application for federal waiver to provide certain dental care for certain persons.

Expand Medicaid dental services for Medicaid Adults (over 21 years of age) that have been diagnosed with diabetes (type 1 or 2) to improve oral health and lead to better overall health and quality of life.

Section 1

• Authorizes the Department of Health and Human Services to apply for an 1115 demonstration waiver through the Centers for Medicare & Medicaid Services to expand Medicaid dental services for individuals 21 years and older that have been diagnosed with diabetes.

Subsection A

 Section a: applies to patients with well controlled glycemic levels and good oral hygiene

Subsection B

• Section b: applies to patients with long standing diabetic conditions with poor glycemic control and compromised oral hygiene.

Section 3 and 4

 Requires the health maintenance organization or managed care organization that administer Medicaid services to provide written notices to newly diagnosed diabetics and to coordinate with any entity necessary to ensure eligible Medicaid recipients receive dental benefits.




Assembly Bill 223

Hypothesis of CMS 1115 Demonstration Waiver:

By expanding Medicaid dental services and specifically including dental prophylaxis benefits for adults with diabetes, the oral and systemic health of this population will improve, and medical expenses associated with the condition will decrease.

Waiver Metrics:

- By providing dental services, patient health will improve through:
 - A1c level decrease
 - Control of blood pressure
 - BMI
- By providing dental services, medical expenditures will decrease through:
 - Less emergency and hospital encounters
 - Trend of number and types of medications prescribed over time
 - Utilization of consistent medical/dental services
- By providing dental services, quality of life improves through:
 - Use of social services over time
 - Quality of life survey results
 - Nutritional survey results





Focused Expansion of Services for Waiver Application

Eligible Population for New Adult Dental Waiver Benefit

- Adults (21 years to 64 years of age) who are:
- Enrolled in Nevada Medicaid;
- Diagnosed with type I or type II diabetes; AND
- Receive services at a Federally Qualified Health Center (FQHC) in Nevada under agreement with Division to participate as a provider in the waiver demonstration.

Note: Currently two FQHCs will be participating:

- a. Nevada Health Centers
- b. Community Health Alliance



Focused Expansion of Services for Waiver Application

Service Limits & Budget Neutrality Requirements

- State must ensure federal spending under the waiver remains within the budget neutrality projections approved by CMS.
- Therefore, Division is proposing an annual service limitation on the new adult dental waiver benefit as follows:
- No more than **five dental visits** at a participating FQHC will be reimbursable per enrollee, per year.
- Waiver will be over a five year period and can be renewed or amended if needed to adjust this service limitation after the implementation and experience has been measured for use of the new adult dental benefit for this diabetic population.





Goals of Dental 1115 Demonstration Waiver

Implement	Strategy to increase population-based services for those with chronic disease such as diabetes which is currently 11.2% of the Nevada population
Strengthen	Partnership between physicians and dentists to improve both oral and systemic treatment by coordination of care
Improve	Glycemic control and overall health of diabetic patients through periodontal treatments
Reach	National Health Standards
