

## Justice-Involved Reentry Initiatives Advisory Committee Representative Interest

**WE NEED YOU!** Nevada is launching new initiatives in response to state Assembly Bill (AB) 389 (2023) and the federal Consolidated Appropriations Act of 2023 (CAA), which together require Medicaid to cover select services for certain justice-involved populations, including adults, children, and aged out foster care youth. Please see the <u>summary</u> for details. **Input from our community is critical to the success of this work.** There are two ways that community members can get involved: (1) apply to join the Advisory Committee and (2) attend these meetings as a Community Member.

**JOIN THE ADVISORY COMMITTEE.** Why should you join? To share your experiences with pre- and post-release service delivery to justice-involved individuals and provide feedback on Nevada's implementation approach. We'll use your ideas to help improve health for justice-involved individuals across our state. We need at least 20 people with representation from the following groups:

- Correctional Partners with interest in learning more about new Medicaid reimbursement opportunities available through the Reentry Demonstration and requirements for youth under the CAA.
- Adults and Youth with Lived Experience in Nevada's carceral systems (e.g., prisons, state-run and/or county-run jails
  or juvenile justice facilities, and/or residential systems that require transition back to the community).
- Providers, including physical and behavioral healthcare providers and correctional healthcare providers.
- Provider Organizations, including provider associations and managed care organizations.
- Counties, including Washoe, Clark, and rural counties.
- Community Partners, such as reentry and social service providers, peer support specialists and community health workers.
- Advocacy and Non-Profit groups, including legal aid and groups representing consumers, families, and/or children involved in the carceral system in Nevada.
- State Agencies, such as Divisions of Child and Family Services, Welfare and Supportive
   Services, Public and Behavioral Health, Aging and Dis

Services, Public and Behavioral Health, Aging and Disability Services, and judicial system representatives.



The Advisory Committee will kick off on **Tuesday, March 25, 2025**, from 12:30 – 1:30 pm and will meet virtually on an initial bimonthly cadence, later transitioning to quarterly.
