

Upcoming MSM 400 – Mental Health Services

- Updating MSM 400 for Psychiatric Residential Treatment Facility policy and provider expectations
- Public Workshop December 20, 2024

- Establishing new flat rate as well as add on payments

Upcoming NEW MSM 4200 – FASD Health Home

- Development of new MSM chapter for Health Home for Medicaid beneficiaries with Fetal Alcohol Spectrum Disorder

- Proposed Public Hearing December 30, 2024

Upcoming MSM 400 – Designated Mobile Crisis Team

- Updating requirements for a DMCT, remove peer requirement and how teams are certified


