

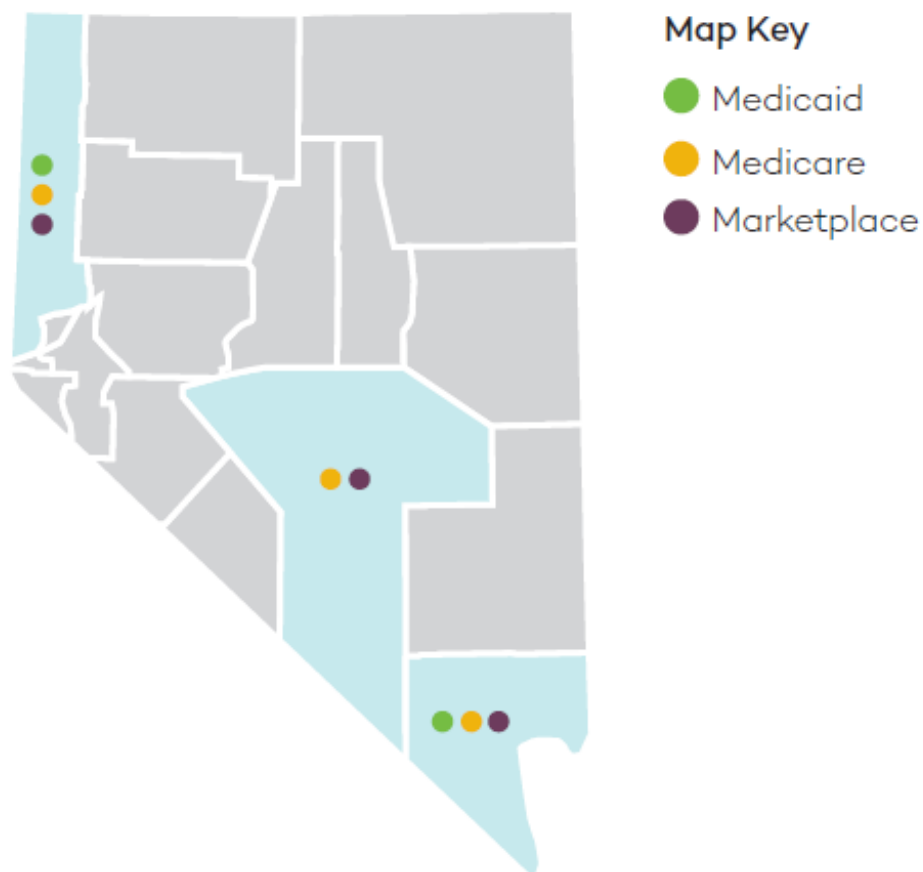

Changes are effective 1/1/26



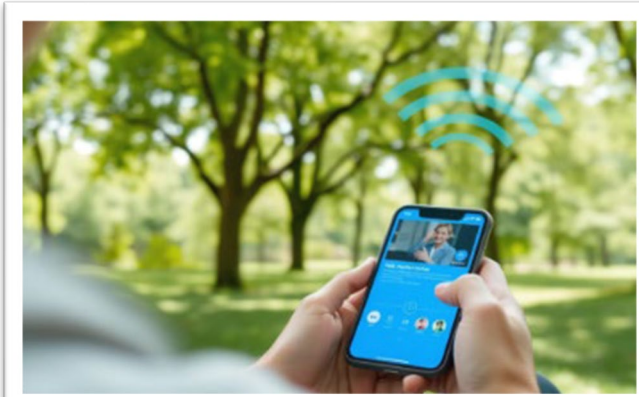

Why Contract with Molina?

- National presence in 20+ states.
- Focus on Medicaid, Medicare, and underserved populations.
- Agreements with providers in surrounding states.
- Dedicated provider support and resources.



Contracting Process Overview

This process begins after Nevada Medicaid Enrollment

- Request a Contract by filling out the Provider Contract Request Form and W-9 and send too: NVprovidercontracting@MolinaHealthcare.com or fax to (844) 303-5188
- You will receive: an acknowledgment to your request a contract packet and a NVDOI Application
- Send the Application and credentialing document checklist by email to the contracting team
- Processing time: 1–2 weeks

Credentialing Requirements

- Documentation Needed: Licenses, certifications, CAQH profile, NPI, insurance.
- Verification Process: Education, licenses, malpractice history.
- Timeline: 30–60 days typical.
 - Nevada Medicaid has centralized credentialing, so the forms needed and timing are all now in coordination with the state vendor



Final Steps & Approval

- **Committee Review:** Quality, compliance, accessibility, cultural competency.
- **Outcomes:** Approval, conditional approval, request for more info, or denial.
- **Welcome Email:** Includes writing number – ready to see Molina members.



The Final Step

Ongoing Relationship with Network

- Recredentialing: Every 3 years or as required.
- Updates: Maintain CAQH, licenses, insurance, training.
- Communication: Use Molina's provider portal (Avality) for claims, eligibility, updates.

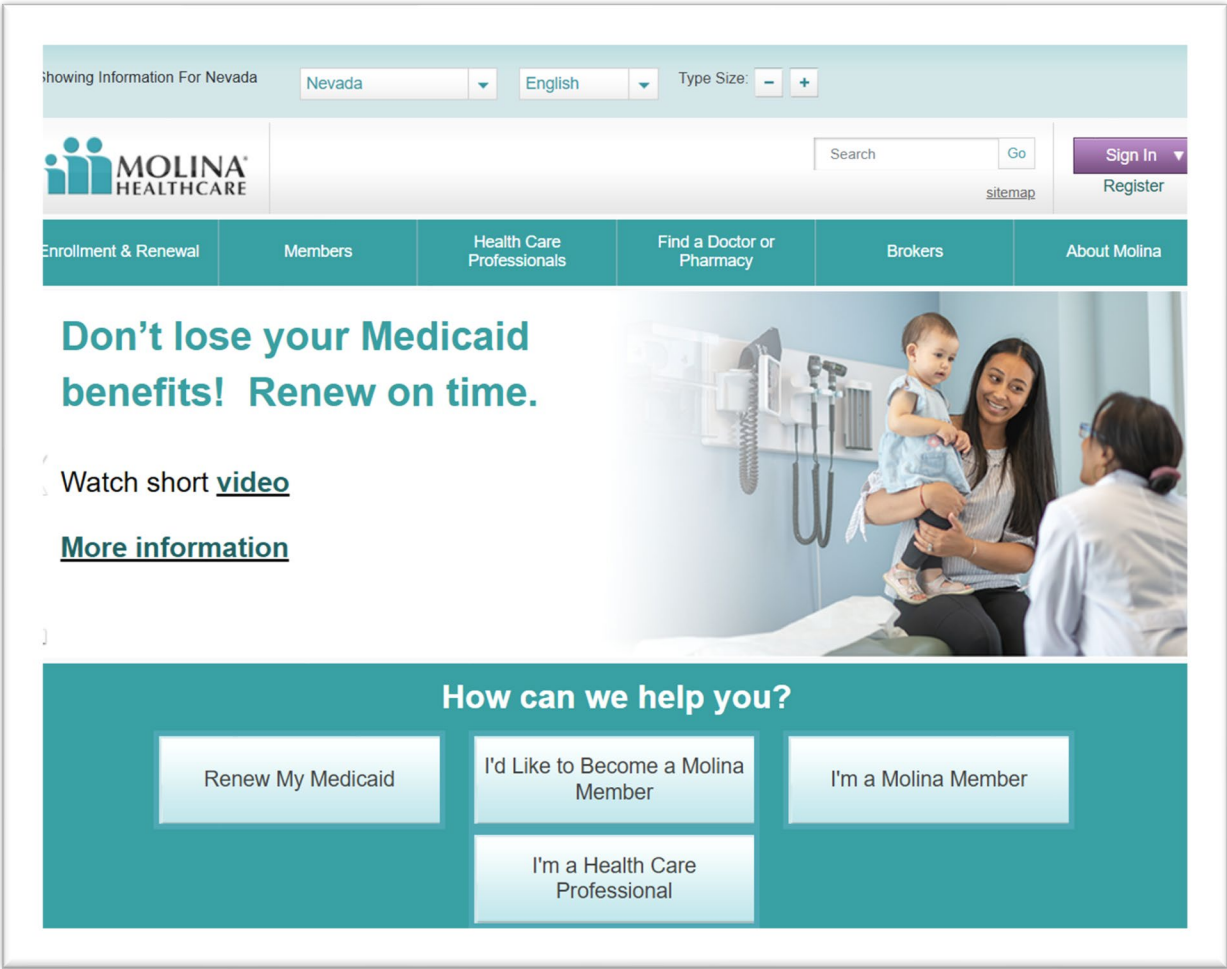

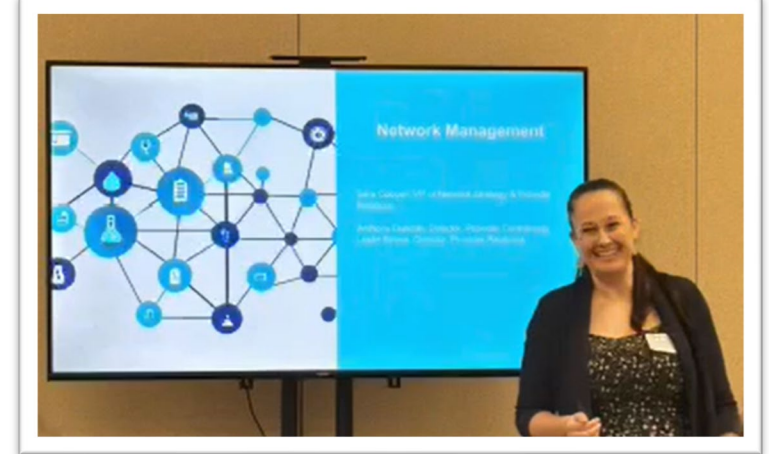
